SUMMARY

The Washoe County Law Library is the recipient of a donation totaling \$120.36 from the David Hamilton Trust Account to fund our ongoing operations. The Washoe County Law Library plans to use these funds to purchase books to support its mission.

Other prior donations, independent of this item, have been accepted on behalf of the Washoe County Law Library.

BACKGROUND

On June 30, 2021, the David Hamilton Trust Account sent a letter which included a donation check in the amount of \$120.36. The mission of the Washoe County Law Library, in part, is to enhance access to justice by providing legal information, education, resources, tools, and materials, in print and digital formats. The donation provided by the David Hamilton Trust Account will be used to purchase books to support the mission and to help ensure the legal needs of the community are addressed.
