BACKGROUND

During the summer of 2025, the Sparks Senior Center underwent a construction project to install new flooring. During the approximately two weeks of construction, the center was unusable for participants. Our Savior Lutheran Church allowed Senior Services to utilize their space for senior activities during this time at no cost to the County.

Per NRS 224.1505, a board of county commissioners may expend money for a grant or donation to a nonprofit organization created for religious, charitable or educational purposes through a resolution.

FISCAL IMPACT

Sufficient FY26 budget authority exists within the Senior Services (225) fund and Payments to Other Agencies (710400) account in the Human Services Agency's FY26 approved budget. This action requests approval and distribution of a total of [\$250].
