PREVIOUS ACTION

BACKGROUND

On December 21, 2023, Library Board of Trustees Chair Frank Perez resigned midway through his term. In response to notices of the vacancy in local newspapers, the County website, and the Library website, the Washoe County Library System received applications and resumes from 89 applicants for the Trustee vacancy, which are appended to this report.

The Board of Trustees of the Washoe County Library System are appointed by the Washoe County Commissioners in accordance with NRS 379.020(3) and are responsible for governing the operations of the Washoe County Library System. The Board of Trustees appoints the Library Director and evaluates his or her performance, helps set Library goals and objectives, approves policies, monitors the Washoe County Library System's finances, evaluates the system's overall effectiveness, and advocates for the Washoe County libraries in the community.

NRS 379.020(1) requires the Board of County Commissioners to appoint members to the Washoe County Library Board of Trustees. Individuals appointed must be residents of Washoe County and must be competent pursuant to NRS 379.020(1). The Board of Trustees has recommended the following criteria to be used when evaluating applicants:

- Demonstrate use and appreciation of libraries;
- Experience working with public libraries;
- Other work experience;
- Volunteer experience;
- Community involvement; and
- The Commission District where the applicant resides.
