### **SUMMARY**

The Second Judicial District Court has been awarded \$40,000.00 from the State of Nevada, Administrative Office of the Courts in grant funding to support the integration of an existing E-filing with new CMS.

### **PREVIOUS ACTION**

No previous Board action.

### **BACKGROUND**

Second Judicial District Court requested grant funding from the Administrative Office of the Courts to assist with the integration of its E-filing system to a new CMS solution. The integration will include 1) data element mappings, filtering, throttling, queuing, transaction record retention period, and resending/republishing of messages 2) Frequency/trigger information, specification of data transport mechanism requirements, port and firewall rules, and secure networking requirements and 3) monitoring and reporting requirements, identification of exception types and processing of transactions, and bandwidth requirements based on expected transaction volumes

**GRANT AWARD SUMMARY**

**Project/Program Name:** *District Court AOC Case Management System*

**Scope of the Project:**

To integrate the Second Judicial District Court’s existing e-filing solution with a new CMS. The buildout of this two-way interface between the two systems will include:

**Benefit to Washoe County Residents:** *To deploy a modern case management system (CMS) for the Second Judicial District Court that will improve efficiency in case processing and support digital access.*

**On-Going Program Support:** *Once initial interface is tested and approved, any additional changes will be at an additional cost.*
