SUMMARY

Washoe County Regional Animal Services has been awarded \$20,000.00 from Petco Love Foundation to support the expansion and marketing of pet reunification efforts.

PREVIOUS ACTION

No previous action.

BACKGROUND

Regional Animal Services' reunification efforts aim to actively reunite pets with their owners – both in the field and from the shelter. While we have a return-to-owner success rate of 37% (one of the best in the nation), WCRAS consistently embraces new methods to improve.

Petco Love Foundation recently reached out to Regional Animal Services offering grant funds to support pet reunification efforts through a lost and found pet texting program. This program provides the opportunity for citizens who find a stray animal or have lost a pet to more easily report a pet lost or found. It also provides easier access to additional information on how to reunite a lost or found pet.

This builds on previous grant funding to implement public microchip scanning stations to allow the public to scan a pet for a microchip and reunite them with their family before taking the pet to the shelter.
