Major Incident Summary for August 2025

- Aug 2: Peavine Fire in Cold Springs. 119 acres, no structure loss. (TM and BLM jurisdiction)
- Aug 3: Ridge Fire north of Cold Springs. 2 acres, no structure loss. (BLM jurisdiction)
- Aug 9: Structure fire at 5300 block of Sun Valley. 5 individuals displaced.
- Aug 12: Flat Fire in Cold Springs. 3 acres, no structure loss (BLM jurisdiction)
- Aug 14: Rancho Fire in Rancho Haven. 1,482 acres, no structure loss (TM and BLM jurisdiction)
- **Aug 18:** Structure fire in Rancho Haven at the 16000 block of Red Rock Road. 2 individuals displaced.
- **Aug 23:** Crews stopped a 5-acre fire off of Estate Road in the North Valleys. No structure loss. (TM jurisdiction)
















August 2025 - Number of Incidents by Geographic Location: 1,935




August 2025 Incidents by TM Battalion








August 2025 Mutual and Automatic Aid Provided - Career Stations









August 2025 Mutual and Automatic Aid Received
