SUBJECT: Recommendation to approve the budget amendments and net-zero, cross-fund budget appropriation transfer totaling [\$12,500.00; no county match] in revenues, expenditures, and transfers to the State of Nevada Department of Health and Human Services TB Clinic and NNPH 9th Street Modernization Grant; and direct Finance to make the appropriate budget amendments; (All Commission Districts.) FOR POSSIBLE ACTION.

SUMMARY

Northern Nevada Public Health is requesting the Washoe County Board of County Commissioners (Board) approve a budget amendment of \$12,500.00 in both revenue and expenditure to State of Nevada Department of Health and Human Services, Division of Public & Behavioral Health TB Clinic Grant retroactive to July 1, 2023, through December 31, 2026..

The Remodel Project, located at 1001 E. 9th Street, involves the renovation and improvements of the existing Building B, to provide more efficient and effective staff work areas. Specifically, the Remodel Project will include necessary items such as furniture, fixtures and equipment (FF&E) that will be installed. Work and materials in support of this project will be procured and delivered following the federal and state requirements associated with the use of ARPA funds.

Washoe County Strategic Objective supported by this item: Fiscal Sustainability: Long-term sustainability.

PREVIOUS ACTION

On June 16, 2026 the Board approved budget amendments for \$12,499.00 to support the NNPH 9 Street Modernization.

On October 17, 2023 the Board approved the allocation of SLFRF to support the design and construction of the Northern Nevada Public Health Tuberculosis (TB) Clinic, in the amount of \$10,000,000.00.

BACKGROUND

The Northern Nevada Public Health Tuberculosis (TB) Clinic was the original Scope of Work of the grant award and was completed with the first clients seen at the new building in March of 2026. Funds remained in the grant , and the funder supported the use of remaining funds to modernize the NNPH clinic and office space at the 1001 E 9th Street Office.

The primary building occupied by NNPH was originally constructed in 1977 and is the oldest building on the County Complex. There is limited access to natural light, an outdated clinic flow, and the current space configuration does not allow divisional staff to be located in the same office area. This funding would be used to:

- Construct a Nurses Station that improves provider access to clinic rooms
 - Remove walls to allow for natural light to three large cubicle work areas in the upstairs of Building B
 - Remodel Building C, including the addition of supervisor offices, to accommodate the Air Quality Division
 - Replacement of carpet that was last replaced approximately 20 years ago
 - Updated cubicles for Environmental Health and Air Quality staff
 - New office configuration in the clinic to allow the CCHS Division staff to all be located in the Clinic area
 - And if funding allows, remodel the public restrooms in Building B to meet ADA standards
- Designs and layout of cubicles and office space are based on the Washoe County Future of Work guidance.

The grant funds must be fully expended and invoiced by December 2026. Allowing Manager Thomas to authorize contracts will expedite the contract process and assist in meeting the tight deadline for completion of projects. This is a collaborative project between NNPH and Community Services Department Engineering & Capital Projects.
