TRUCKEE MEADOWS FIRE PROTECTION DISTRICT RESOLUTION TO AMEND THE DISTRICT'S FISCAL YEAR 2024-2025 EMERGENCY MEDICAL SERVICES FUND BUDGET FROM ADDITIONAL RESOURCES IN THE AMOUNT OF \$50,755

WHEREAS, The Board of Fire Commissioners have accepted the donation of assets from Inter-Hospital Coordinating Council in the valued amount of \$39,124 for functionality in support of Truckee Meadows Fire Protection District's Emergency Medical Services (EMS) Division; and

WHEREAS, the capital equipment received includes two (2) Lucas CPR devices, a mechanical chest compression system, for a total value of \$36,465.

WHEREAS, the non-capital equipment and supplies received include accessories for the Lucas CPR devices for a total value of \$2,659.

WHEREAS, The Board of Fire Commissioners have accepted a sub-grant award from Washoe County to provide for the purchase of one Toxic Medic Kit retroactive in the amount of \$5,317 as part of the 2025 Nevada State Emergency Response Commission, Operations, Planning, Training and Equipment Grant, passed through from Washoe County.

WHEREAS, The Board of Fire Commissioners have accepted a grant award from the State of Nevada's Division of Public and Behavioral Health in the amount of \$6,314 for the purchase of a training skin for the District's cut suit. The cut suit is used in trauma scenarios that may occur during emergency medical services calls.

WHEREAS, the Truckee Meadows Fire Protection District is committed to excellence, service, and the protection of life and property in the community; and

WHEREAS, Truckee Meadows Fire Protection District responds to an average of 8,600 medical calls each year; and

WHEREAS, reliable and up-to-date equipment ensures EMS Responders are providing the very best service possible to our community,

WHEREAS, anticipated resources exceeding those estimated resources of the Fiscal Year 2024-2025 EMS Fund revenues are available for use in the EMS Fund expense and cash flow accounts in accordance with NRS 354 and which appropriations are required to be amended as follows:

Section 1. The budget of the Truckee Meadows Fire Protection District EMS Fund be amended as follows:

Increase Revenues:

Section 2. This Resolution shall be effective on passage and approval.

NOW, THEREFORE, BE IT RESOLVED that the Truckee Meadows Fire Protection District shall amend its Fiscal Year 2024-2025 budget by reallocating \$50,755 from the EMS Fund Revenues Accounts for use in the EMS Fund Cashflow for Capital Purchases and non-capital equipment and supplies expense accounts, and further that the District shall forward the necessary documents to the Department of Taxation, State of Nevada.
