CONSTITUTIONAL MANDATE



Sixth Amendment

"In all criminal prosecutions, the accused shall enjoy the right to a **speedy and public trial**, by an **impartial jury** of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be **informed** of the nature and cause of the accusation; to be **confronted** with the witnesses against him; to have **compulsory process** for obtaining witnesses in his favor, and to have **the Assistance of Counsel for his defence**."

CONSTITUTIONAL MANDATE



Gideon v. Wainright 372 U.S. 335 (1963)

- Right to counsel in criminal action is fundamental constitutional right.
- Government has the obligation to provide <u>effective</u> assistance of counsel to those who cannot afford it.
- Funding indigent defense is a cost of the prosecution function.








Trials That Went Forward (Felony & Gross Misdemeanor)



TRIAL DATA: DISTRICT COURT










Percentage of Cases Where Felony/Gross Misdemeanor Trial Was Vacated After Pretrial Motions







Alternate Public Defender: Family Court



GOAL:

Help build safe and secure families to reduce trauma, separation, and entry into the legal system



In the first four years after aging out of foster care, approximately 20% of former foster youth will experience homelessness.

61% of former foster youth experiencing homelessness are likely to be incarcerated compared to 46% of homeless youth who had never been in the child welfare system.

By age 17, over 50% of foster children will have an encounter with the juvenile legal system through arrest, conviction or detention. In addition, 25% of youth in foster care will be involved with the criminal legal system within two years of leaving foster care. If a child has moved to five or more placements, they are at a 90% risk of being involved with the criminal legal system.

One study showed that <u>70% of former foster care youth</u> were arrested at least once before age 26.
