Budget Extension Request for Additional Inspection, Testing, and CM Services**

Dear Mr. Cwiak:

Construction Materials Engineers would like to submit this budget extension request to provide additional inspection, testing, and construction management services for the Station 35 project.

Our scope of work to date on the above-referenced project has required a level of effort that is on pace to exceed the resource allocation in our original proposal. The additional efforts put into the project to date include:

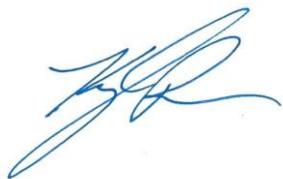
- Additional testing services during mass grading and earthwork operations, including senior inspectors, additional density testing, further laboratory testing, and additional management and coordination efforts with the Contractor and Geotechnical Engineer.
- Additional inspection hours to observe and document earthwork operations.
- Transition to bi-weekly on-site progress meetings (effective 10/1/25) instead of virtual meetings.
- Additional project change review and processing (BACs and PCOs) in excess of the initially proposed quantity of 15 change packages. As of the date of this submission, a total of 45 change packages have been processed and executed, with more expected before the project's completion.
- Additional coordination efforts with the Design Team, Contractor, and Apple concerning the addition of an arsenic treatment system to the facility.
- Additional inspection hours to observe and document the installation of the added treatment system.
- Additional submittal and RFI tracking and coordination efforts, including production of weekly submittal and RFI reports to aid the Contractor and Design Team in managing workflows.
- Additional coordination meetings with the Contractor and Design Team, in addition to the pre-construction and progress meetings included in the original proposal.

Due to increased utilization of our services, we are on pace to exceed the original total contract amount of \$362,852.50. The costs for the additional services are outlined in the attached cost workup, which totals \$91,022.50. The cost workup assumes the project duration remains unchanged and final completion is achieved on time.

If this is acceptable to you, we request an amendment to our original contract for this project or a purchase order for the additional services. We appreciate the opportunity to provide our services to TMFPD. If you have any questions or require further information, please do not hesitate to call.
