# **SUMMARY**

The District Board of Health must authorize travel reimbursements for non-County employees.

- **5. Organizational Capacity:** Strengthen our workforce and increase operational capacity to support a growing population.

#### **PREVIOUS ACTION**

On January 25, 2024, the District Board of Health authorized travel and travel reimbursement for Dr. John Novak for FY24-25 in the approximate amount of \$7,000.00.

On January 26, 2023, the District Board of Health authorized travel and travel reimbursement for Dr. John Novak for FY23-24 in the approximate amount of \$7,000.00

On March 24, 2022, the District Board of Health authorized travel and travel reimbursement for Dr. John Novak for FY22 in the approximate amount of \$6,009.30.

On April 27, 2021, the District Board of Health authorized travel and travel reimbursement for Dr. John Novak for FY21 in the approximate amount of \$2,800.

On May 23, 2019, the District Board of Health authorized travel and travel reimbursement for Dr. John Novak for FY20 in the approximate amount of \$5,500.

#### **BACKGROUND**

The National Association of Local Boards of Health (NALBOH) Board meeting was held in Washington, DC from February 24 through 26, 2025, and Mr. Reese represented the District Board of Health at the meeting. The cost of travel for this trip included airfare, lodging, per diem, and ground transportation, at \$1767.10.
