SUMMARY

The Washoe County Housing and Homeless Services division requests the Board retroactively accept a donation from SilverSummit Healthplan, a health insurance agency, to Washoe County Housing and Homeless Services in the amount of [\$240,000.00] in support of case management services for people experiencing homelessness at Nevada Cares Campus and Our Place as well as Justice involved case management embedded within Washoe County jails and detention centers; and direct the Comptroller's Office to make the necessary budget amendments.

BACKGROUND

SilverSummit Healthplan, a health insurance agency, supports clients served by Washoe County Housing and Homeless Services through health insurance and resources.
