On November 14, 2023, the Board of County Commissioners approved item 8.G.1, the Agency's request to accept a FY24 Federal Title IV-B 1 sub-grant award from the State of Nevada Department of Health and Human Services, Division of Child and Family Services (DCFS) in the amount of [\$62,004.00; \$20,668.00 county match] retroactive from July 1, 2023 to June 30, 2024 to improve outcomes for children and families involved with Washoe County Human Services Agency.

On November 15, 2022, the Board of County Commissioners approved item 9.E.2, the Agency's request to accept a FY23 Federal Title IV-B 1 sub-grant award from the State of Nevada Department of Health and Human Services, Division of Child and Family Services (DCFS) in the amount of [\$62,004.00; \$20,668.00 county match] retroactive from July 1, 2022 to June 30, 2023 to improve outcomes for children and families involved with Washoe County Human Services Agency.

On January 25, 2022, the Board of County Commissioners approved item #6.F.2, the Agency's request to accept a FY22 Federal Title IV-B1 subgrant from DCFS in the amount of [\$62,004.00; \$20,668.00 county match] retroactive from July 1, 2021, to June 30, 2022, to provide child welfare services with a focus on keeping families together.

On November 10, 2020, the Board of County Commissioners approved item #8.K.2, the Agency's request to accept a FY21 Federal Title IV-B 1 sub-grant from DCFS in the amount of [\$62,004; \$20,668 county match] retroactive from July 1, 2020, to June 30, 2021, to provide child welfare services with a focus on keeping families together.

On October 13, 2020, the Board of County Commissioners approved item #5.F.2, the Agency's request to accept a FY21 Supplemental IV-B 1 sub-grant from DCFS in the amount of [\$62,500; \$20,833 county match] retroactive from July 1, 2020, to September 30, 2020, to provide for staffing at Our Place Family Shelter where placement of families for emergency housing will support keeping families together.

On August 31, 2020 the Board of County Commissioners approved item #5.G.5, the Agency's request to accept a FY21 Coronavirus Aid Relief and Economic Security (CARES) Act, Federal Title IV-B1 sub-grant award from DCFS in the amount of [\$82,028; no county match] retroactive from July 1, 2020 to June 30, 2021 to provide child welfare services related to increased or alternative needs due to the coronavirus pandemic with a focus on keeping families together.

## **BACKGROUND**

Title IV-B Subpart 1 of the Social Security Act, also called the Stephanie Tubbs Jones Child Welfare Services Program, primarily supports formula grants to state, tribal, and territorial child welfare agencies for provision of services to children and their families. Additional funds are provided to courts to improve handling of child abuse and neglect proceedings. Finally, some Title IV-B dollars are provided on a competitive basis to various public or private entities for support of research, evaluation, training, or other grants intended to improve or expand provision of child welfare-related services.

Title IV-B of the Social Security Act is an important funding stream for child welfare. It provides funding for many activities including protecting and promoting the welfare of all children, preventing the neglect, abuse or exploitation of children, and support at-risk families. Prior to 2019, the State had not issued a Notice of Subaward (NOSA) for Title IV-B funding.

The Agency received the Notice of Award for this sub-grant on November 30, 2024, with an effective date of October 1, 2024; therefore, the request to accept this award is retroactive.
