SUBJECT: Recommendation for appointment to the Air Pollution Control Hearing Board as an At-Large Committee Member. Staff recommends the appointment of Mr. Chaitanya Korra for a three-year term beginning on February 27, 2025, and concluding on February 26, 2028. Applicants include William Foster McCoy, Ph.D., and Stephen Birdsall.

SUMMARY

In accordance with the District Board of Health Regulations Governing Air Quality Management SECTION 020.000.C.1, Hearing Board Creation and Organization, staff is recommending the District Board of Health (DBOH) appoint Mr. Chaitanya Korra to the Air Pollution Control Hearing Board (APCHB) as an At-Large Board Member for a three-year term beginning on February 27, 2025, and concluding on February 26, 2028.

PREVIOUS ACTION

August 26, 2015, DBOH approved the initial appointment of Mr. Lee Squire to the APCHB as an At-Large Board Member for a three-year term beginning on August 26, 2015, and concluding on September 27, 2018.

On December 16, 2021, DBOH approved Mr. Lee Squire's re-appointment to the APCHB as an At-Large Board Member for a three-year term beginning on December 16, 2021, and concluding on December 15, 2024.

On December 15, 2024, Mr. Lee Squire completed his term and stepped down from the Air Pollution Control Hearing Board, leaving his seat open for reappointment.

BACKGROUND

The APCHB, as established in regulation, considers appeals of notice of violation issued by the Air Quality Management Division and petitions for variances authorized by the regulations. The APCHB consists of seven (7) members who are not employees of the state or any of its political subdivisions. Pursuant to NRS 445B.275, the membership is required to include one attorney admitted to practice law

in Nevada, one member must be a professional engineer licensed in Nevada and one member must be licensed in Nevada as a general engineering contractor or a general building contractor as defined by NRS 624.215. Terms are established by regulation to be three-year periods.

On November 1, 2024, and January 15, 2025, the Air Quality Management Division (AQMD) issued a press release soliciting community members to apply for the APCHB. The press release was posted to the AQMD website. In addition, the AQMD sent the press release to the email addresses of all individuals who have subscribed to the AMQD email list. Emails were also sent to various organizations, including all District Board of Health (DBOH) members and Nevada Chapter AGC. Lastly, the AQMD posted the press release on social media such as Facebook and Twitter. The press release remains on the AQMD website under public outreach and can be found at the following link (OurCleanAir.com). Lastly, it was reported during the division updates at recent DBOH meetings. A copy of the application form is available on the [website](#), and the AQMD will continue to accept applicants indefinitely.
