On October 31, 2023, FHN Financial Main Street Advisors, LLC ("FFMSA") entered into an Assignment and Purchase Agreement with Meeder Investment Management, Inc. ("Meeder") whereby FFMSA's assets will be acquired by Meeder (the "Transaction"). As a result, after the completion of the Transaction, current FFMSA employees will become employees of Meeder, and Meeder's wholly-owned subsidiary, Meeder Public Funds, Inc., will assume the operations of FFMSA. The Transaction is expected to close by mid-December 2023, subject to customary closing conditions.
