### SUMMARY

Accept a donation of 47 Narcan Kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$2,115] donated by Quest Counseling and Consulting Inc.

**Washoe County Strategic Objective supported by this item:** Vulnerable Populations: Support vulnerable populations with regional approach.

### PREVIOUS ACTION

On January 16, 2024, the Washoe County Board of Commissioners accepted a donation of 73 Narcan Kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$3,285] donated by Quest Counseling and Consulting Inc.

On August 15, 2023, the Washoe County Board of County Commissioners accepted a donation of 50 Narcan kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$3,750] donated by Quest Counseling and Consulting Inc.

On May 25, 2021, the Washoe County Board of County Commissioners accepted a donation of 44 Narcan Kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$3,300] donated by Quest Counseling and Consulting Inc.

**BACKGROUND**

Quest Counseling and Consulting Inc. has donated 47 Narcan Kits to Juvenile Services, valued at approximately \$45 per kit, to support emergency response efforts to prevent opioid overdoses for community members served by Juvenile Services.

Narcan is a critical, life-saving medication used by first responders to provide immediate treatment in suspected opioid overdose situations. Through this donation, Juvenile Services Probation Officers will have access to Narcan in the field, enhancing their ability to respond promptly should they encounter an individual experiencing a possible opioid overdose in our community.

Quest Counseling and Consulting, Inc has been a valued community partner, working collaboratively with the Washoe County Department of Juvenile Services to provide a comprehensive continuum of substance abuse and mental health assessments and treatment services for youth and families.

**FISCAL IMPACT**

There is no fiscal impact.

**RECOMMENDATION**

It is recommended that the Board of County Commissioners accepts a donation of 47 Narcan Kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$2,115] donated by Quest Counseling and Consulting Inc.
