POSSIBLE ACTION

SUMMARY

Historically, Washoe County receives an annual allocation of funds through the Secure Rural Schools Act (SRS Act). The SRS Act has expired and was not reauthorized, therefore the payments this year are distributed under the 1908 Act Amended legislation. This Act distributes the average of 25 percent of 7 fiscal years of receipts from each national forest and is paid to the State or Territory in which said forest is situated, to be expended for the benefit of the public schools and public roads of the county or counties in which the forest is situated. Under the 1908 Act Title I, II, III does not exist, and 100% of funds are for roads and schools. Each State decides for themselves on the percentage breakdowns between their public roads and schools. The \$4,472.16 received is 50% of the distribution from the USDA Forest Service and is allocated to Washoe County to be used for roads within the County. The other 50% is directed to the Washoe County School District.

PREVIOUS ACTION

On June 25, 2024, the Board of County Commissioners (Board) accepted \$18,161.48 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2021.

On June 27, 2023, the Board of County Commissioners (Board) accepted \$21,226.82 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2021.

On June 28, 2022, the Board accepted \$22,514.97 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2020.

On May 18, 2021, the Board accepted \$17,277.34 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2019.

The Board has accepted funds annually when they have been received.

BACKGROUND

Funding is provided to States from the U.S. Forest Service under the 1908 Act Amended legislation. The program objective is to share receipts from the National Forests with the states and counties in which the forests are located. Funds are distributed equally between the Washoe County School District and Washoe County. Washoe County's share of funds is to be used for the benefit of public roads within the County.

Due to an accounting treatment error, funds were received in April 2025 but are now being requested for acceptance.

Scope of the Project: Funding is provided to States and Counties from the U.S. Forest Service under 1908 Act Amended. The program objective is to share receipts from the National Forests with the states in which the forests are situated.
