Welfare of the Inmates

- ▶ Welfare of inmates in custody includes these factors:
 - ▶ Health of inmates
 - ▶ Access to medical care
 - ▶ Infectious disease and vermin control
 - ▶ Food services
 - ▶ Environmental controls
 - ▶ Safety of inmates
 - ▶ Out of cell time

Welfare of Inmates

COVID-19 Update

- ▶ Steps taken to mitigate COVID-19 threat to jail population
 - ▶ Cancelled most in person contact with inmates
 - ▶ Increased iWeb, telephone, email access
 - ▶ Resumed inmate transports outside facility
 - ▶ Resumed inmate programming
 - ▶ Continued COVID-19 pre-screening station in Intake
 - ▶ Issued masks to inmates upon request traveling outside their assigned housing unit
 - ▶ COVID vaccines available to all inmates upon request

Health Risk

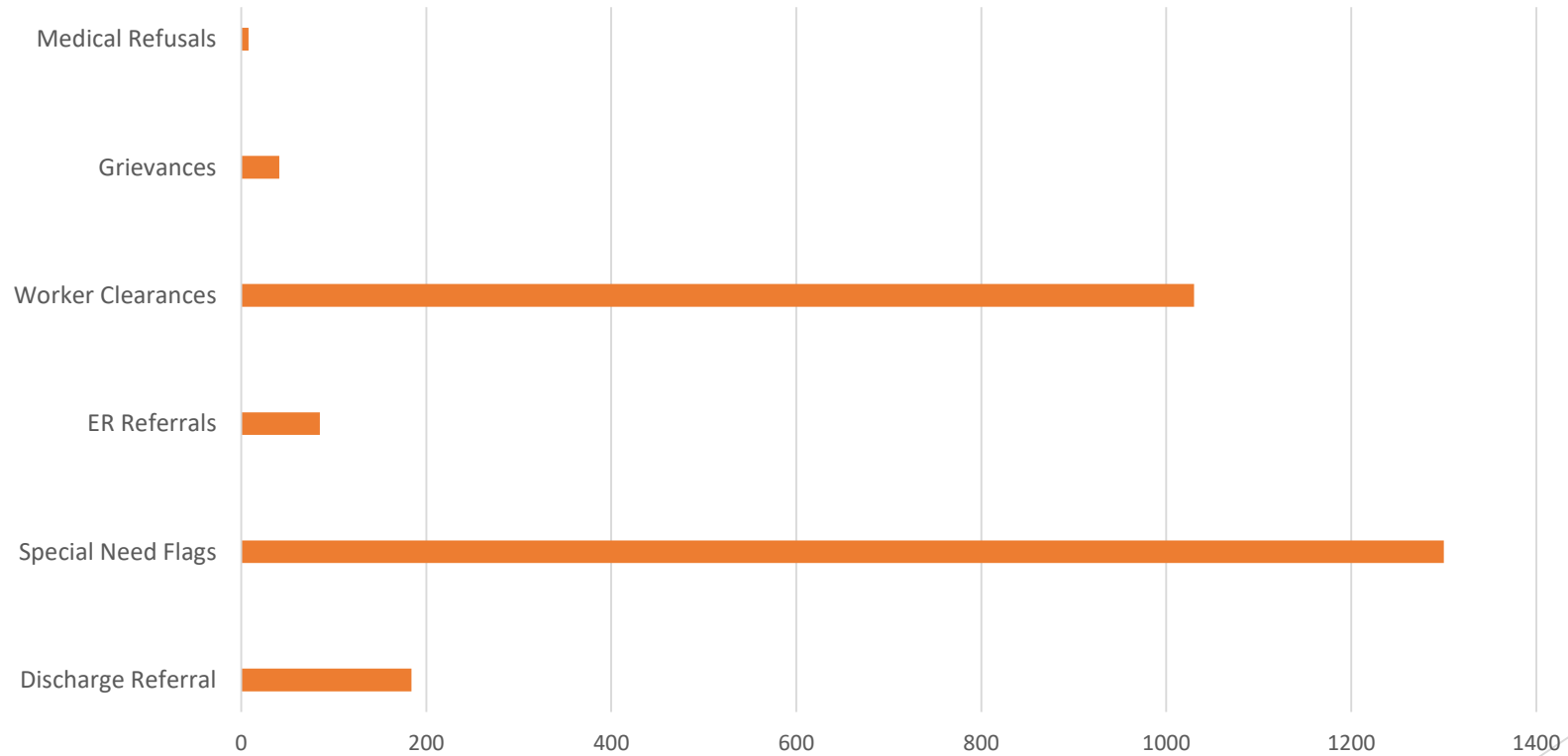
- ▶ Fentanyl introduction remains a problem.
 - ▶ 4 Overdose incidents this quarter, 1 was fatal
 - ▶ When legally supported, unclothed searches are conducted on arrestees.
 - ▶ Body scans are conducted on inmates prior to housing.
 - ▶ Protocols for decontamination of cells and clothing have been adopted for inmate and staff safety
 - ▶ Naloxone is available throughout the facility and staff are trained in its application

Welfare of the Inmates

- Bunk Project will be completed April 15
 - ▶ This will make the cells safer as there are no longer spaces where sheets can be readily attached to bunks.
 - ▶ A minor increase in capacity was achieved

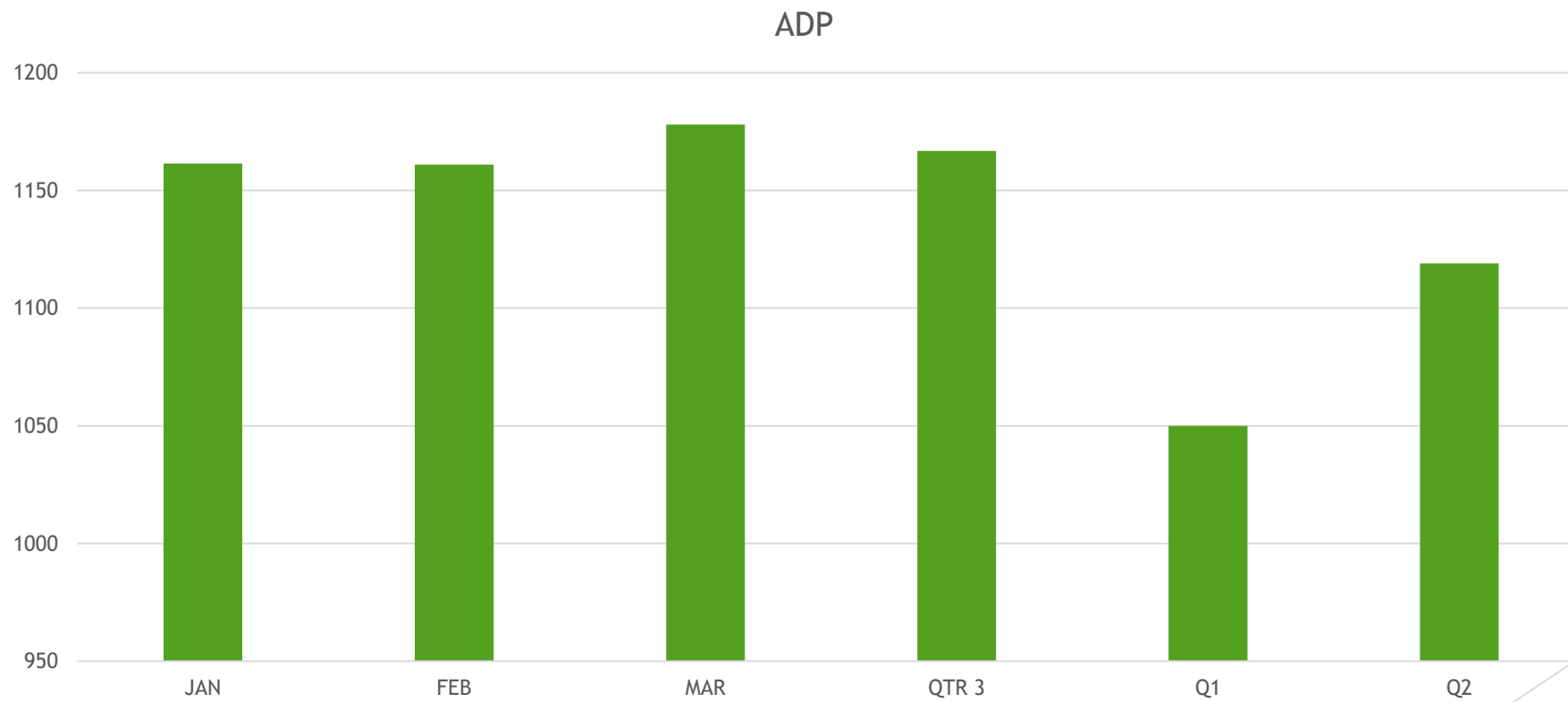

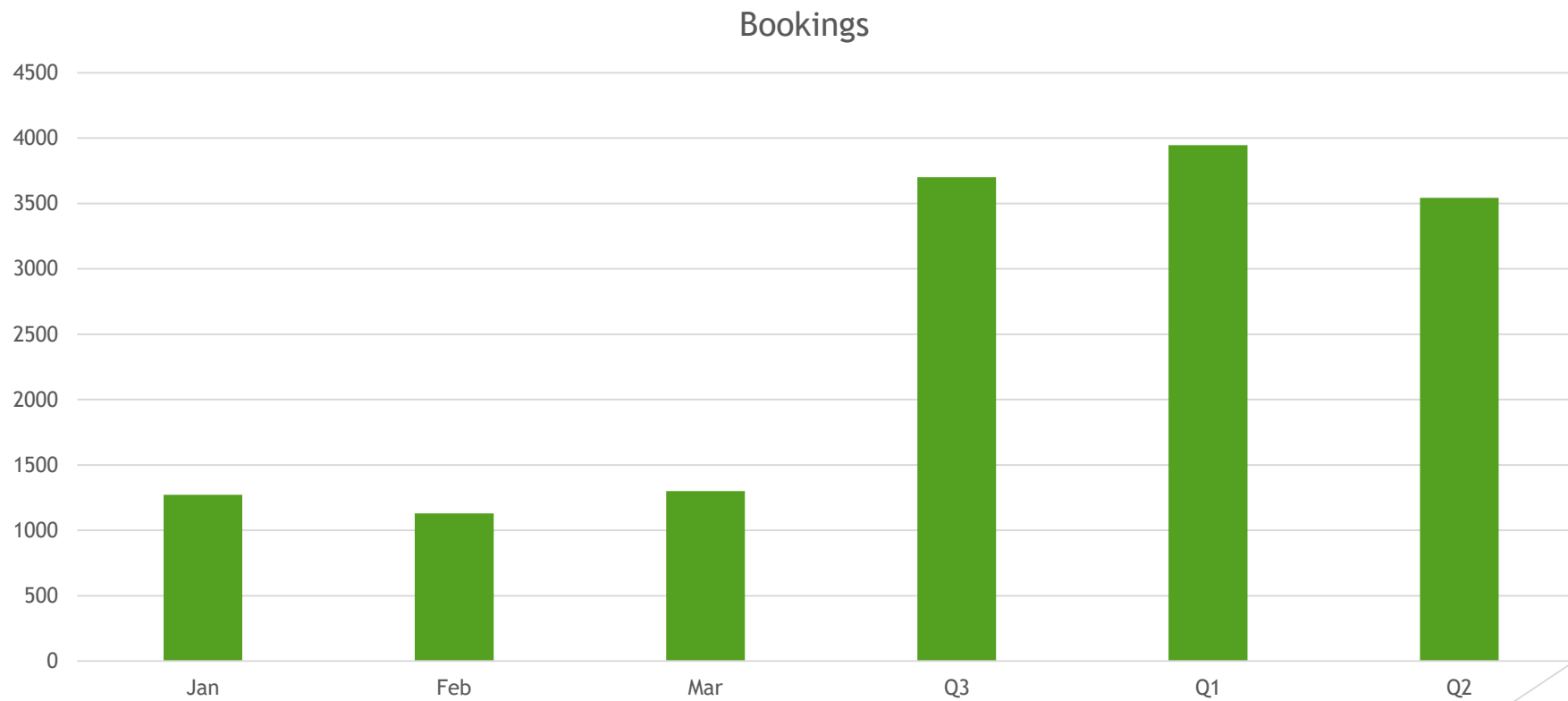

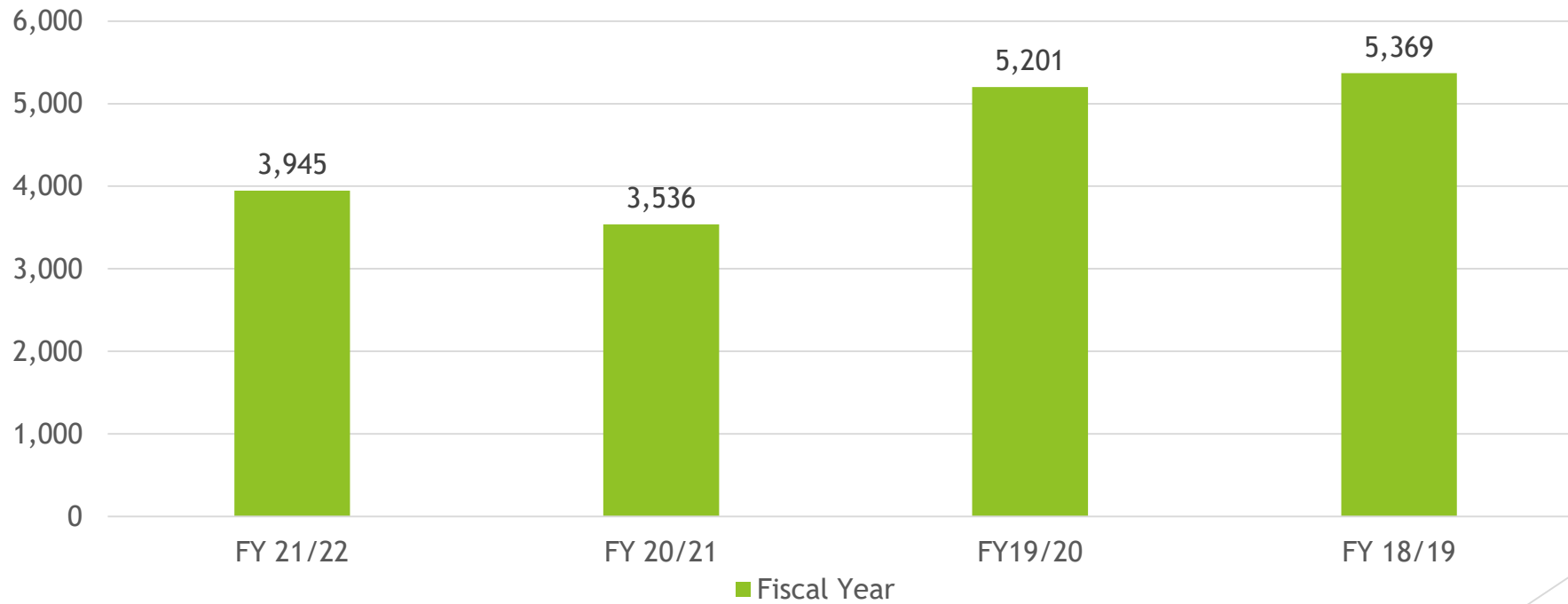


21/22 3rd Quarter Bookings

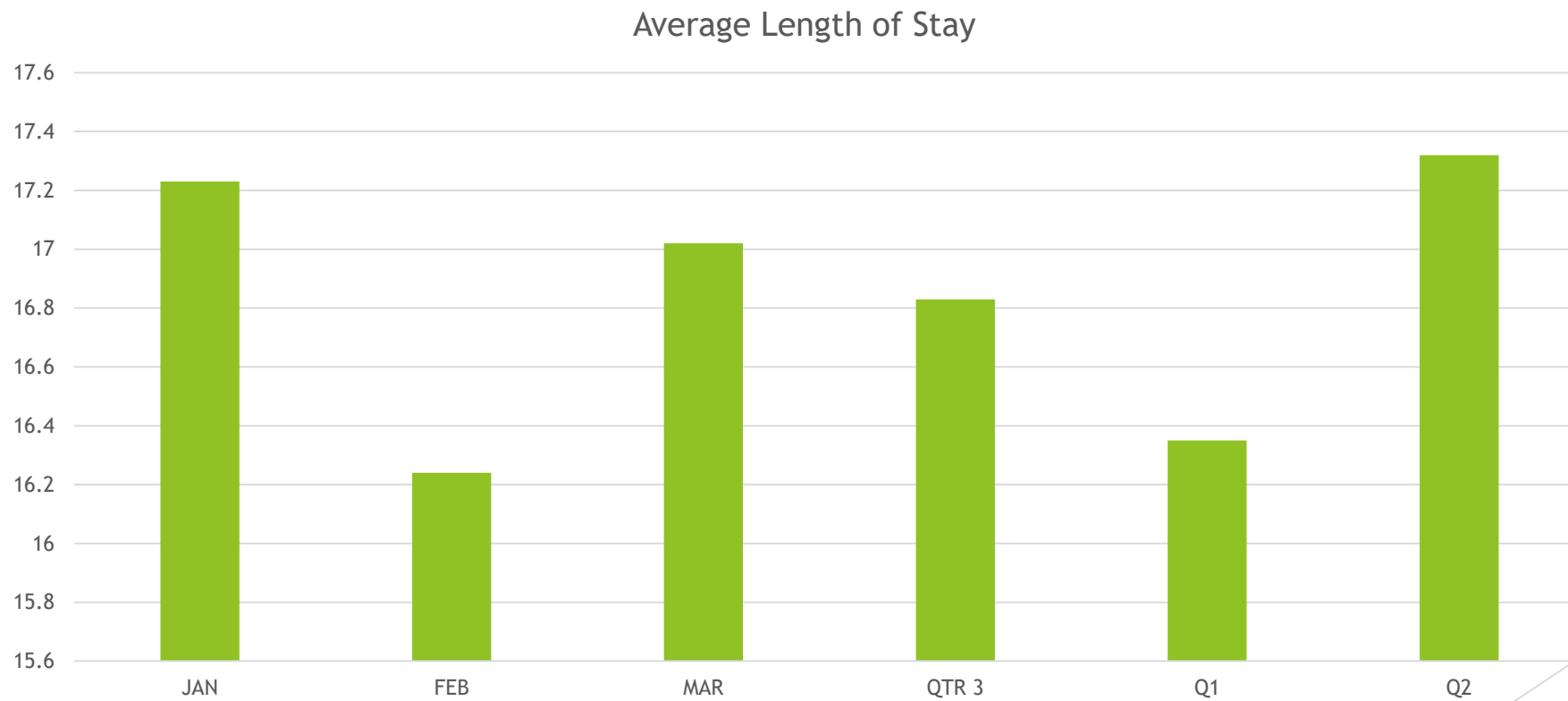

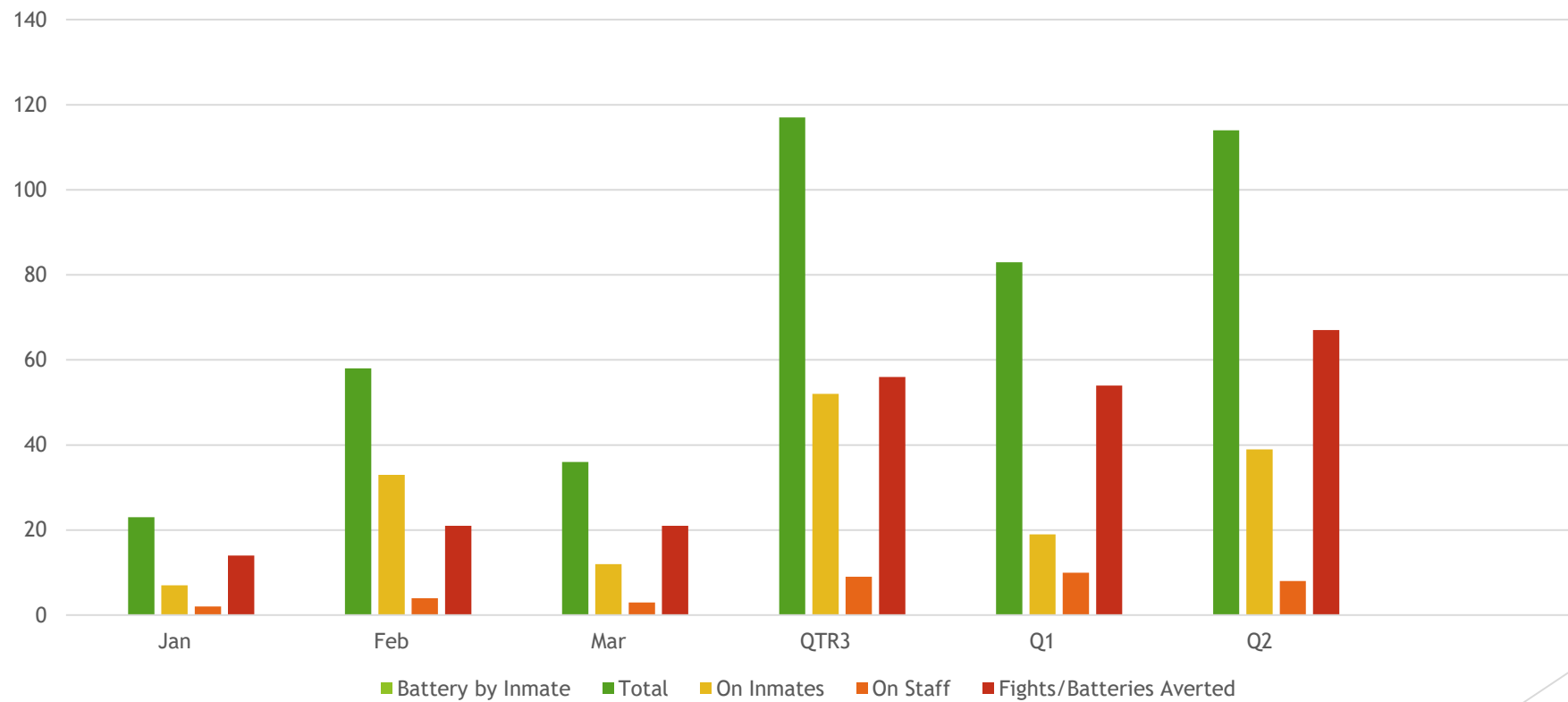

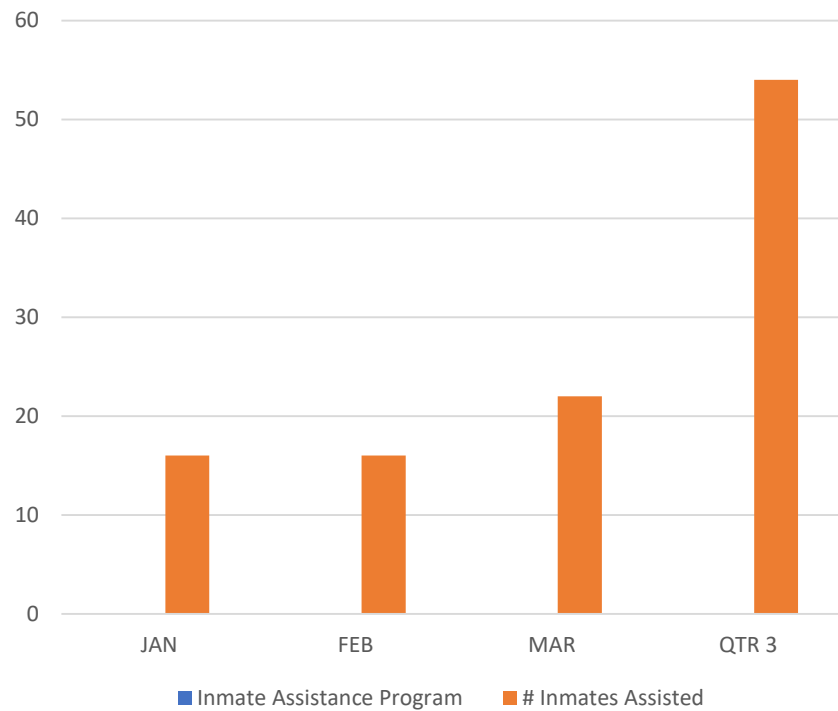

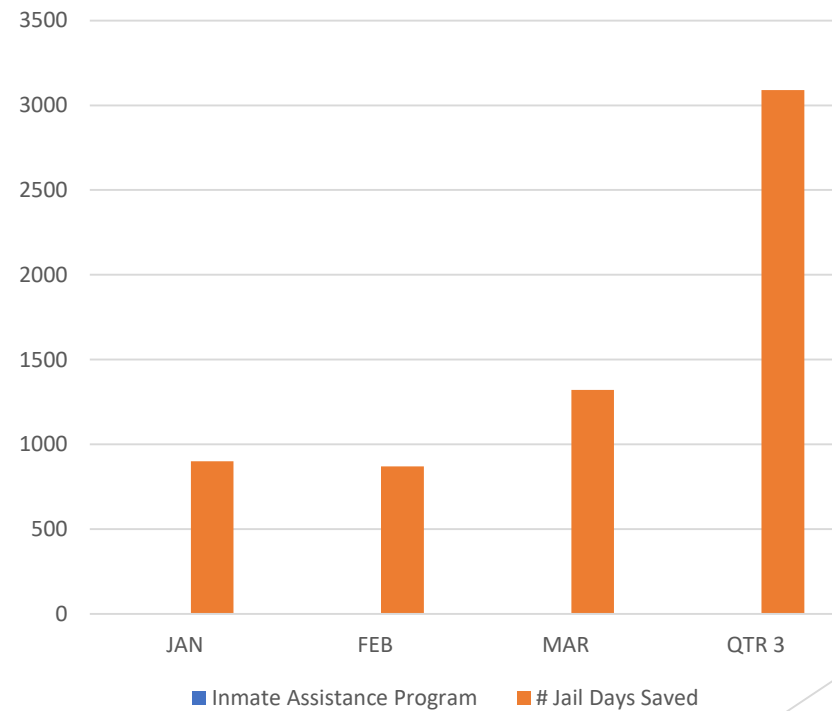


FY 21/22 3rd Quarter Inmate Assistance Program (DSU) Cost Savings
