FIFTH AMENDMENT

VOTING SYSTEM AGREEMENT BY AND BETWEEN LIBERTY VOTE USA INC. AND WASHOE COUNTY, NV

This Fifth Amendment to the Voting System Agreement ("Fifth Amendment") is made and entered into as of this August 26, 2025 (the "Fifth Amendment Effective Date") by and between Washoe County, NV ("Customer") and Liberty Vote USA Inc.

RECITALS

WHEREAS, following a change in ownership, Dominion Voting Systems, Inc. is now Liberty Vote USA Inc.;

WHEREAS, the Customer and Liberty Vote entered into the VOTING SYSTEM AGREEMENT BY AND BETWEEN LIBERTY VOTE USA INC. AND WASHOE COUNTY, NVE (the "Original Agreement") with the effective date June 29, 2017, for the Customer's purchase from Liberty Vote of certain voting systems, licenses, and related solutions, which was amended by a First Amendment on December 1, 2019, a Second Amendment on June 1, 2020, a Third Amendment on August 1, 2023, and a Fourth Amendment on September 1, 2024 (collectively, the Original Agreement, First Amendment, Second Amendment, Third Amendment, and Fourth Amendment are referred to herein as the "Agreement");

WHEREAS, the Customer and Liberty Vote desire to amend the Agreement; and

THEREFORE, in consideration of the mutual covenants and obligations herein contained, and other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Customer and Liberty Vote agree as follows:

AMENDMENT

- 1. **Recitals Incorporated.** The above recitals are true and correct and incorporated herein by this reference as if fully set forth.
- **2. Amendment of Paragraph 3.** Paragraph 3 of the Amendment is amended to read as follows:
 - "3. Term of Agreement. The Term of this Agreement shall begin on the Effective Date and shall continue until December 31, 2030, with two one-year optional extensions. Customer must exercise each extension option in writing before the end of the then-current term."
- **3.** Amendment of Paragraph 9. Paragraph 9 of the Agreement is amended to read as follows:
 - 9. Warranties

- 9.1. <u>Liberty Vote Software Warranty.</u> The Liberty Vote Software warranty is subject to the terms and conditions of Exhibit B Software Terms and Conditions.
- 9.2. <u>Third Party Products.</u> The warranties in this Section 9 do not apply to any third party products. However, to the extent permitted by the manufacturers of third party products, Liberty Vote shall pass through to Customer all warranties such manufacturers make to Liberty Vote regarding the operation of third party products.
- 9.3. <u>Liberty Vote Hardware Warranty</u>. Liberty Vote warrants that when used with the hardware and software configuration purchased through or approved by Liberty Vote, each component of Liberty Vote Hardware will be free of defects that would prevent the Liberty Vote Hardware from operating in conformity in all material respects with its specifications as documented by Liberty Vote. The Liberty Vote Hardware Warranty shall remain in effect during the Term of this Agreement.
- 9.4. <u>Liberty Vote Hardware Warranty Conditions.</u> Liberty Vote offers the following hardware warranty services, subject to the conditions listed herein.
 - 9.4.1.If any Liberty Vote Hardware component fails to operate in conformity with its specifications during the warranty period, Liberty Vote shall provide a replacement for the Liberty Vote Hardware component or, at Liberty Vote's sole option, shall repair the Liberty Vote Hardware component, so long as the Liberty Vote Hardware is operated with its designated Liberty Vote Software and with third party products approved by Liberty Vote for use with the Liberty Vote Hardware.

9.4.1.1. On-Site Warranty Services.

9.4.1.1.1. Liberty Vote shall perform one (1) on-site Preventative Maintenance Inspection every even numbered year on Liberty Vote Hardware during the Agreement Term. The preventative maintenance inspection shall occur at a time mutually agreed upon by the Parties during 2026, 2028, 2030 and 2032. The Parties agree that the preventative maintenance shall be scheduled at least ninety (90) days prior to the requested maintenance date.

9.4.1.1.2. Liberty Vote shall conduct one (1) Customer On-Site Visit annually, during which Liberty Vote will perform warranty repair services on any Customer equipment that the Customer has identified as needing repair. To the extent any warranty services cannot be performed on-site, the equipment will be shipped back to Liberty Vote for repair or replacement. Customer shall bear all shipping costs to return any malfunctioning Hardware component to Liberty Vote, and Liberty Vote shall bear the costs for shipping the repaired or replaced Hardware component to Customer.

9.4.1.2. Off-Site Warranty Services.

- 9.4.1.2.1. If warranty services are required outside the Preventative Maintenance Inspection or Customer Site Visits described above, Customer may ship any malfunctioning hardware to Liberty Vote for warranty services. Customer shall bear all shipping costs to return any malfunctioning Hardware component to Liberty Vote, and Liberty Vote shall bear the costs for shipping the repaired or replaced Hardware component to Customer.
- 9.4.2. The following services are not covered by this Agreement, but may be available at Liberty Vote's current time and materials rates:
 - 9.4.2.1. Replacement of consumable items, including but not limited to batteries, paper rolls, ribbons, seals, smart cards, and removable memory devices, scanner rollers, disks, etc.; or
 - 9.4.2.2. Repair or replacement of Liberty Vote Hardware damaged by accident, disaster, theft, vandalism, neglect, abuse, or any improper usage.
 - 9.4.2.3. Repair or replacement of Liberty Vote Hardware modified by any person other than those authorized in writing by Liberty Vote; or
 - 9.4.2.4. Repair or replacement of Liberty Vote Hardware from which the serial numbers have been removed, defaced, or changed.

- 9.5. No Other Warranties. LIBERTY VOTE DISCLAIMS ALL OTHER REPRESENTATIONS AND WARRANTIES, WHETHER WRITTEN, ORAL, EXPRESS, IMPLIED OR STATUTORY, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND ANY WARRANTY BASED ON A COURSE OF DEALING, COURSE OF PERFORMANCE, OR USAGE OF TRADE.
- **3. Addition of Exhibit A-5**. Exhibit A-5, attached hereto and incorporated by this references, is hereby added to the Agreement immediately following Exhibit A. All references to "Exhibit A, Exhibit A-1, Exhibit A-2, Exhibit A-3, and Exhibit A-4" in the Agreement are hereby replaced with references to "Exhibit A, Exhibit A-2, Exhibit A-3, Exhibit A-4 and Exhibit A -5."
- **4.** Amendment of Exhibits A, A-2, A-3, and A-4. All references to ongoing license and warranty fees after the Fifth Amendment Effective Date are hereby removed from Exhibits A, A-2, A-3, and A-4. All ongoing license and warranty fees due after the Fifth Amendment Effective Date are now listed in Exhibit A-5.
- **5. All Other Terms.** Except as expressly amended in this Fifth Amendment, all other Agreement terms shall remain in full force and effect.

IN WITNESS WHEREOF, the parties have executed this Fifth Amendment to the Agreement to be effective as of the Fifth Amendment Effective Date.

Payments specified in this Exhibit are exclusive of all excise, sale, use and other taxes imposed by any governmental authority, all of which taxes (other than income taxes owed by Liberty Vote) shall be reimbursed by Customer.

3. Product Description

3.1. Product Description

- ImageCast® Precinct Tabulator (ICP). ImageCast® Precinct Scanner and Tabulator is an optical scan ballot tabulator used to scan marked paper ballots, interpret voter marks on the paper ballot, communicate these interpretations back to the voter and upon voter acceptance, deposits the ballot in the ballot box. The ImageCast consists of the following:
 - o Two (2) optical imaging scanners for creating duplex scanned image of each side of the ballot. Ballots can be fed in all four (4) orientations.
 - Linux Operating System.
 - Two (2) SD memory card ports for storage capabilities. Two (2) 8GB
 SD memory cards will be provided and located behind two securable doors (Administrator Door and Pollworker Door).
 - An integrated interactive electronic display in the form of an ultra-high contrast graphical color 5.7" LCD screen, and a built-in touch screen for administration purposes.
 - An internal 3" thermal printer and one (1) 3" paper roll for generating reports.
 - One (1) administrative security key (iButton) used with an integrated receptacle (physically attached to the top of the unit and electrically

- connected to the motherboard) used for a variety of verification and security tasks such as control, data confidentiality and integrity functions.
- o A motorized paper feed mechanism for detecting and moving the ballot within the scanner. Ballots used with the ImageCast must be 8.5" wide by a variable length (11", 14", 17", and 22"). The paper feed mechanism is physically capable of moving the ballot forward into the machine, across image sensors, enabling complete image capture of both sides of the ballot.
- o An internal battery which meets or exceeds certification standards.
- Patented functionality known as AuditMark. For each ballot scanned and accepted into the unit, a corresponding ballot image is created and stored for audit purposes. The image consists of two parts below:
 - The top portion of the image contains a scanned image of the ballot.
 - The bottom portion consists of a machine-generated text showing each mark that the unit interpreted for that particular ballot. This is referred to as the AuditMark.
- 3.2. *Ongoing telephone support*. Telephone support shall be available for Customers during the Term of the Agreement at no additional costs.
- 3.3. *Travel and Expenses included.* All costs of Liberty Vote transportation, lodging and meal expenses are included during the Agreement Term.
- 3.4. *Other Services, Consumables or Equipment.* Any other services, consumables or equipment not specifically identified in this Agreement are available for purchase by the Customer at the then current Liberty Vote list price.
