Food Safety Plan Review & Operations

Special Processes & Program Standards Team

- December 1st - 4th staff, Ryan Rennie and Olivia Alexander-Leeder, traveled to Bellingham, WA to mentor the Whatcom County food safety inspection team as part of the NACCHO Mentorship Program which supports interjurisdictional collaboration, strengthening food safety practices, and building a national food safety network.
- Staff hosted two AMC Program Courses, which were attended by representatives from 18 food establishments.

Food Safety Plan Review

- Office hours every Tuesday in December have been busy with stakeholders inquiring about how to build a restaurant and change of ownership.
- The team has been busy with food establishment change of ownerships in December and construction inspections for plan review to end the year out.

Temp Foods / Special Events / Mobile Foods

- In December, the team worked included 39 North Pole Village in Victorian Square in Downtown Sparks, The Holiday Lights Festival at City Plaza in Downtown Reno and Winter Wonderland at the Atlantis.

Food Operations Enforcement and Investigations:

Permit Suspensions

Ongoing enforcement activities related to continued non-permitted food operations throughout Reno, Sparks and unincorporated Washoe County. Staff continue to partner with other agencies regarding these complaints.

A. *L & L Hawaiian BBQ, H17-0111FOOD, 1495 E Prater Way # 125, Sparks, NV*

NNPH visited the facility to conduct a routine inspection; however, upon entrance NNPH inspector was made aware that the walk-in unit was down. Since the person in charge stated that they did not have enough food in the working equipment they would have to self-close until walk in unit was fixed.

B. *Sbarro, H18-0788FOOD, 5000 Meadowood Mall Cir, Reno, NV*

The health permit was suspended on 12/23/2025 for repeat consecutive critical violations for date marking, cold holding, and time as a public health control. The operator was required to write AMC policies and attend an office hearing prior to permit reinstatement to explain how critical risk factors will be kept in compliance. Operator was also required to bring photos or videos and invoices from a licensed plumber showing floor sink drain is cleared and functioning properly. On 12/24/2025, the office hearing was held and the AMC policies were deferred until the reinspection, and the permit was reinstated. The operator subsequently passed reinspection on 1/5/2026 with policies still outstanding (due by 1/7/2026).

C. *La Mint, H18-1091FOOD, 770 S Meadows Pkwy, Reno, NV*

The health permit was suspended for repeat critical violations for inappropriate date marking (4th finding) and improper cooling (3rd finding) has been observed since July 2023. The operator was required to attend an office hearing and submit an updated AMC policy for date marking and cooling. The office hearing was held on 12/4/2025, and the AMC policies were completed. The operator passed a subsequent facility reinspection on 12/17/2025.

Permitted Facilities

Commercial Plans / Development Reviews

- Commercial Plans increased 72% from the same time last year in December for this past month. Calendar year 2025 finished with 1,704 plan submittals compared to 1,729 plan submittals from 2024, which means the year finished with plans being 1% below 2024.
- EHS received 186 Commercial Plans to review and conducted 281 EHS specific environmental reviews on those plans during the month of December.
 - A total of 1,704 commercial plans were received and a total of 2,479 EHS specific reviews completed.
- 94% of all plans in December 2025 were reviewed within the regional goal of 14 days.
 - 12 plans of the 186 submitted in December did not meet the regional goal for review.

- The program spent the last month completing reinspections and preparing for the next school year and inspections.
- Childcare regulations are pending completion of formatting. Once they have been formatted, the regulations will be reviewed and sent to the State for comment and public forums will be planned to discuss the future regulations with the operators.

Vector-Borne Disease Program

- Program staff continue to winterize mosquito abatement and surveillance equipment.
- The mosquito fish program has been continued into the winter, maintaining a warehouse population, to facilitate earlier mosquito fish request response in the spring.

Environmental Protection

Residential Septic & Well Plan Reviews

- Intake for residential well and septic plans continued to be elevated in December. A total of 73 plans came in, 30 of which were new submittals, compared to 34 in 2024 with 17 being new submittals.
- A project to recover septic and well records from the Washoe Regional Mapping System (WRMS) continued. Working with tech services, staff was able to obtain usable records from the WRMS

system. Staff is in process of checking records and marrying them to the EHS stored property records. Once completed, this will result in all septic and well records being stored in one place for the first time. The project will then move towards making the records easily available to the public.

- Team leadership continued to work with Technology Services throughout December to refine and improve the well and septic record types in Accela. This has included automating the workflow steps for inspectors in the well record to minimize steps, and the development of an automated checklist for test trench inspections in the septic record.
- Team leadership have finalized a form for auditing inspectors while they conduct septic and well inspections and plan review. The form may change with time but has been shared with the inspectors, so they are aware of what they are being audited against. Audits will begin in 2026, and the goal will be to conduct three audits for each inspector each calendar year.
- The Business Impact statement for the proposed septic regulation update went to the Board of Health in December and was approved. Adoption of the regulations is scheduled for the January meeting. The regulations will then go to the State Board of Health for approval in March.

Safe Drinking Water

- One sanitary survey was completed in the month of December. All required sanitary surveys for 2025 were completed and reports sent out.
- Team leadership has begun the process of learning the State's Planner process for water projects. While EHS no longer conducts water project reviews themselves, there are tasks to be completed as facility managers when water systems upgrade their infrastructure. It has long been a goal to handle those tasks consistently with the State utilizing their system. Once leadership is comfortable with the process, staff assigned to the program will be trained as well.

Waste Management / Underground Storage Tanks (USTs)

- All required inspections were completed for calendar year 2025.
- UST staff inspected 23 fuel sites, and 9 compliance document review re-inspections in December.
- Staff received 24 complaints for the month of December and conducted 40 on-site inspections.
- Solid Waste Management staff inspected 29 permitted waste management facilities / liquid waste trucks and conducted one (1) re-inspection. Two new liquid waste trucks were opened and one opening inspection on a waste management permit occurred during the month.
- Staff are continuing to work with the County Manager's Office on a pilot composting program that will require a variance. Staff conducted a site visit and are providing final feedback on the variance request.

- A quarterly update meeting was held with KTMB. The primary topic of discussion was how to incorporate new legislation into practice to help remove junk cars from the desert. Even with the new legislation, there are some challenging hurdles that will be worked on over the next year.
- The senior EHS recruitment yielded 15 candidates, approximately 50%-50% internal and external. Interviews are scheduled for January 12-14.
