### **SUMMARY**

The Board of County Commissioners (Board) is asked to reappoint Rob Pierce to a seat held by Washoe County on the Truckee Meadows Regional Planning Commission (RPC).

Washoe County Strategic Objective supported by this item: Meet the Needs of a Growing Community

### **PREVIOUS ACTION**

On September 10, 2024, the Board set the list of alternates to the RPC as follows: First Alternate, Linda Kennedy; Second Alternate, Amy Owens; Third Alternate, Jim Barnes; and Fourth Alternate, Kate Nelson.

On June 25, 2024, the Board appointed three members for terms beginning July 1, 2024, and ending June 30 of the years identified in parentheses: Michael Flick (2027); Daniel Lazzareschi (2026); and Rob Pierce (2025).

### **BACKGROUND**

Pursuant to NRS 278.0262(c), the Board appoints three members from the Washoe County Planning Commission (PC) to represent Washoe County on the RPC. RPC member terms are three years in length and are staggered. At the present time, the Regional Planning Commissioners representing Washoe County are:

Michael Flick	July 2024 – June 2027

Rob Pierce is serving a one-year partial term on the RPC which began July 1, 2024, and ends June 30, 2025.

Daniel Lazzareschi is serving a two-year partial term on the RPC which began July 1, 2024, and ends June 30, 2026.

Michael Flick is serving his first full term on the RPC which began July 1, 2024, and ends June 30, 2027.

Should the Board agree with staff's recommendation, the Truckee Meadows Regional Planning Commissioners representing Washoe County would be:

Michael Flick	July 2024 – June 2027
Rob Pierce	July 2025 – June 2028

### **FISCAL IMPACT**

Regional Planning Commission members are compensated at a rate of \$80.00 per meeting pursuant to NRS 278.0262(4). The RPC typically meets six times a year, which equates to an annual compensation of \$480 per member. There is sufficient budget authority in FY26 to compensate all RPC members for scheduled meetings in CSD Planning & Development Admin (105400), Volunteer Stipend (710111).

### **RECOMMENDATION**

It is recommended, pursuant to NRS 278.0262(c) and related authorities, to reappoint Rob Pierce, member of the Washoe County Planning Commission to the Truckee Meadows Regional Planning Commission for a full-term beginning July 1, 2025, and ending June 30, 2028; or until such time as a successor is appointed, whichever occurs first.

### **POSSIBLE MOTION**

Should the Board agree with staff's recommendation, a possible motion would be:

“Pursuant to NRS 278.0262(c) and related authorities, move to reappoint Rob Pierce, member of the Washoe County Planning Commission to the Truckee Meadows Regional Planning Commission for a full-term beginning July 1, 2025, and ending June 30, 2028; or until such time as a successor is appointed, whichever occurs first.”
