#### PREVIOUS ACTION

On December 20, 2022, the Board of County Commissioners directed in total [\$10,000.00] to the Washoe County Leadership Academy (WCLA), of which [\$6,000.00] was distributed from Commission District 2 Funds.

On December 13, 2022, the Board of County Commissioners directed [\$10,000.00] to the Boys and Girls Club of Truckee meadows – Neil Road Youth Facility; and [\$5,000.00] to the Washoe County Human Services Agency; and [\$4,000.00] to the Damonte Ranch Mustang Wrestling Club; and [\$4,000.00] to Doral Academy of Northern Nevada; and [\$2,000.00] to Brown Elementary School; and [\$2,000.00] to Double Diamond Elementary School; and [\$2,000.00] to Huffaker Elementary School; and [\$2,000.00] to Hunsberger Elementary School; and [\$2,000.00] to Elizabeth Lenz Elementary School; and [\$2,000.00] to Nick Poulakidas Elementary School; and [\$2,000.00] to Pleasant Valley Elementary School; and [\$2,000.00] to Smithridge Elementary School.

On October 18, 2022, the Board of County Commissioners directed [\$5,000.00] to the South Valleys Library.

### **BACKGROUND**

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015 created Commission District Special Funds for each Commission District. On May 17, 2022 the Board of County Commissioners approved the 2022-2023 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000.00. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable, or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Clark has elected to support the following organization in fiscal year 2022-2023:

- [\$5,000.00] grant to the Down Syndrome Network of Northern Nevada -- a nonprofit organization created for religious, charitable or educational purposes -- to support their mission to advocate for and with individuals with Down syndrome and their families to break down any barriers to full, productive and satisfying lives. The Down Syndrome Network of Northern Nevada seeks to create a positive understanding of Down syndrome and envisions a community wherein all members are valued for their uniqueness, respected for their contributions, and assured the opportunity and choice to create their own path to fulfillment and success.
- [\$5,000.00] grant to the Nevada Youth Empowerment Project -- a nonprofit organization created for religious, charitable or educational purposes -- to support

their mission to give homeless young women (18-24) in the Reno area a chance to reroute their lives through a structured program that provides housing and basic needs, life skills training, opportunities to practice new life skills, and the support and love of a family. The NYEP has created an independent living curriculum that is grounded in standards, routine, consistency and accountability.

- [\$5,000.00] grant to Opportunity Alliance Nevada -- a nonprofit organization created for religious, charitable or educational purposes -- to support their mission of building sustainable communities across Nevada to stabilize and improve the lives of individuals and families. Opportunity Alliance Nevada is a 501(c) (3) charitable nonprofit incorporated in Nevada and the statewide community champion of Prosperity Now.
- [\$5,000.00] grant to the Robert Unsworth Foundation -- a nonprofit organization created for religious, charitable or educational purposes -- to support their mission to provide tennis equipment and instruction to public schools and youth groups. The Robert Unsworth Foundation was created following the sudden passing of 22-year-old Reno tennis player and instructor of the same name, in order to give everyone an opportunity to experience the joys of tennis.
- [\$5,000.00] grant to Truckee Meadows Housing Solutions -- a nonprofit organization created for religious, charitable or educational purposes -- to support their mission to further the public good, namely by adding more low-income units (60% AMI or less) to the housing inventory. The We the People curriculum is an innovative course of instruction on the history and principles of the United States constitutional democratic republic.

The Sanford Center for Aging is able to provide services to their clients such as transportation, companionship, wellness programs, and more.

Forever 14 was founded in memory of Caleb Stenvold who passed in 2019, and now works to raise awareness and reduce teen suicide by developing and implementing peer to peer programs at the middle and high school level.

The Great Basin Chaplain Corps operate and are developing specialty teams ranging from but are not limited to, law enforcement, fire, displaced populations, EMS, hospice, hospital, peer support, financial, training, community outreach/public information, human trafficking, and more.
- [\$2,500.00] grant to the India Association of Northern Nevada -- a nonprofit organization created for religious, charitable or educational purposes -- to support their goal to bring the citizens of the Indian subcontinent together to promote and celebrate rich Indian heritage. The India Association of Northern Nevada was founded in 1980's to create a positive and enjoyable environment to nurture friendships and celebrate festivals.

The Neighbor Network of Northern Nevada (N4) supports people with intellectual and developmental disabilities, dementia, and related conditions, as well as their family care partners through their Community Care Program.
