

#### **Mission**

The mission of the Washoe County Public Guardian's Office is to serve as guardian, by court appointment, for vulnerable individuals 18 and older who are unable to manage their personal and financial affairs, by coordinating provision of services, providing informed consents on their behalf, and protecting, preserving, and managing their assets.

#### NRS 159 and NRS 253

NRS 159 Describes the General Provisions of Adult Guardianships, Court Proceedings, Powers and Duties of the Guardian, Management of large and small estates, the Protected Person's Bill of Rights, duties of guardians to family and interested parties, and establishes the Guardianship Compliance Office.



NRS 253 Describes the establishment of the Public Guardians, qualifications, powers and duties, and the ability for guardians to request an advance of county funds to assist in managing a protected person's estate.



\*Many other statutes that grant guardians authority depending on circumstances.



#### Standards and Ethics of Guardian





National Guardianship Association adopted a code of ethics in 1991 to help guide guardianship practice.



In 2000 NGA Developed 7 original standards.



In 2022, after 4 subsequent revisions, the NGA presented the current 25 standards we have today.



Includes Practical Standards and Aspirational Principles



Intentional language to imply duties, create discretion in authority, recognize mandates and prohibitions, and highlight rights of individuals.



## How to Spot A Good Guardian

#### A Good Guardian:


- Treats the person under guardianship with dignity
- Involves the person in all decision making, to the greatest extent possible
- Places the least restrictive options on the person's freedoms and rights
- Maximizes the self reliance, dignity, and independence of the person
- Respects that the money and property that is being managed belong to the person
- Adheres to the highest professional standards and ethical principles defined by the State and the National Guardianship Association



**Ages of Clients** 




## Average Length of an Active Guardianship Case: 8 years, 11 months






#### Caseload 1:24 Ratio\*

#### **Recommended 1:20**






#### **Caseload Numbers 2025**






### **Time Spent Managing Personal and Real Property**






## **Referred to Guardianship with Homes**








