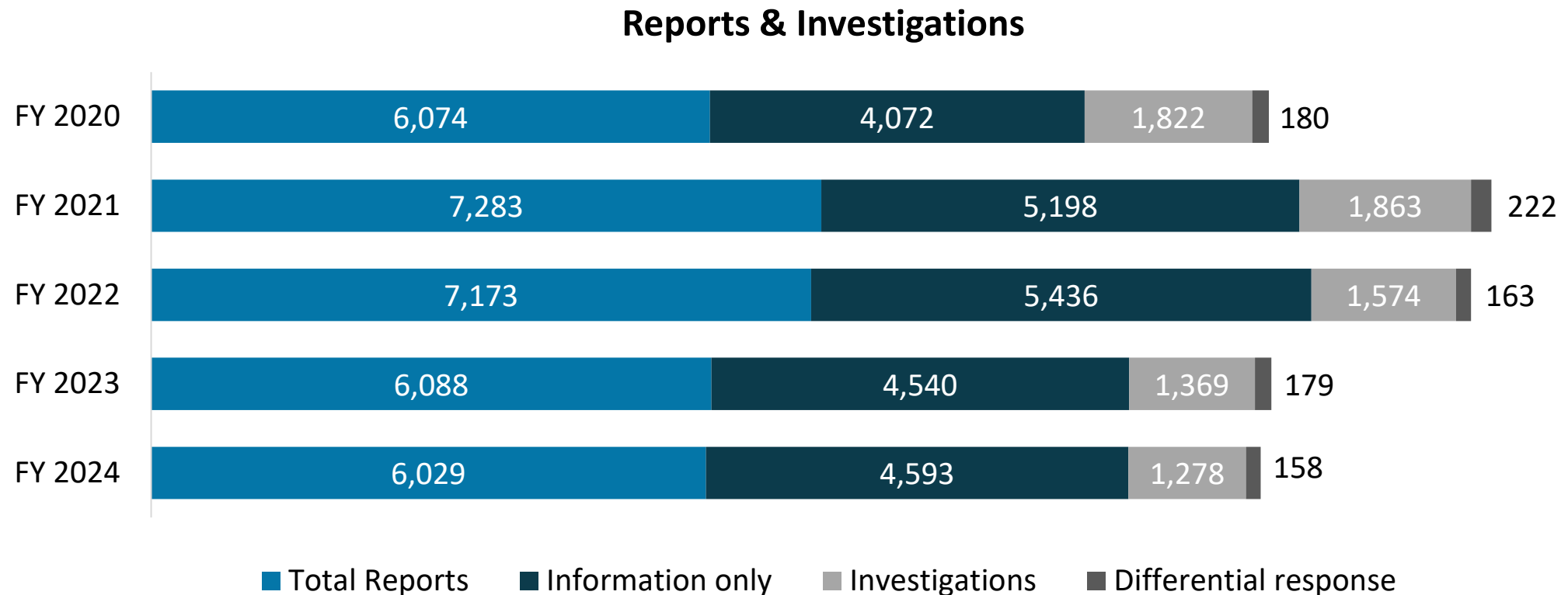
Child welfare's mission is to support and educate families and the community to ensure that children's basic health and safety needs are met in their primary family or other permanent setting. We collaborate with families and the community to assess family strengths, safety issues, and risk of harm to children. We seek to deliver services that assure the safety of children while building upon the strengths of the family.

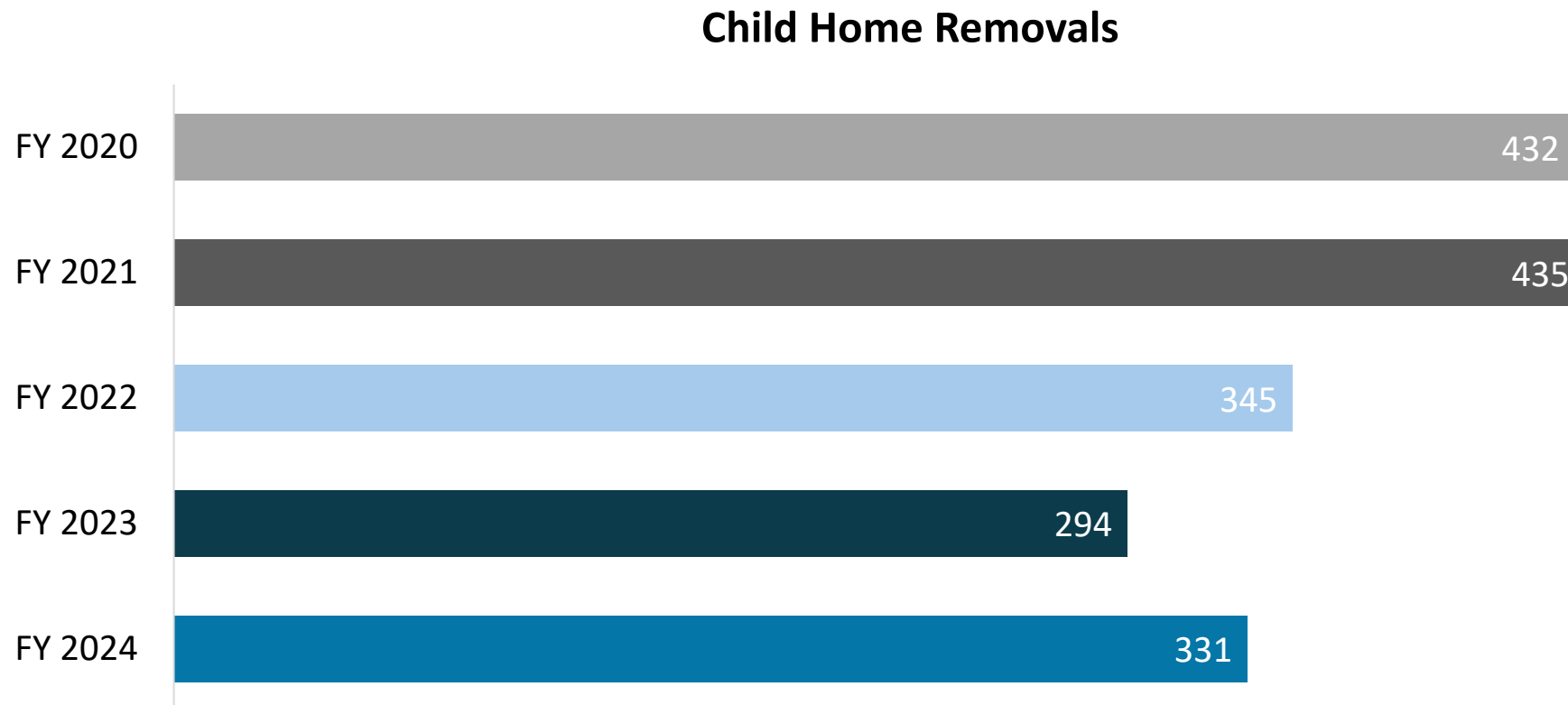
# Reports

Child Protective Services (CPS) is a major system of intervention of child abuse and neglect. The first and most critical step in the child protection process is Intake. It begins with CPS staff receiving a confidential report, which is an allegation of abuse or neglect from an external source. Based on the information received from the report, it is assigned a priority level determined on the allegation and amount of imminent risk or danger the child may be in. This leads to what response is required from CPS.



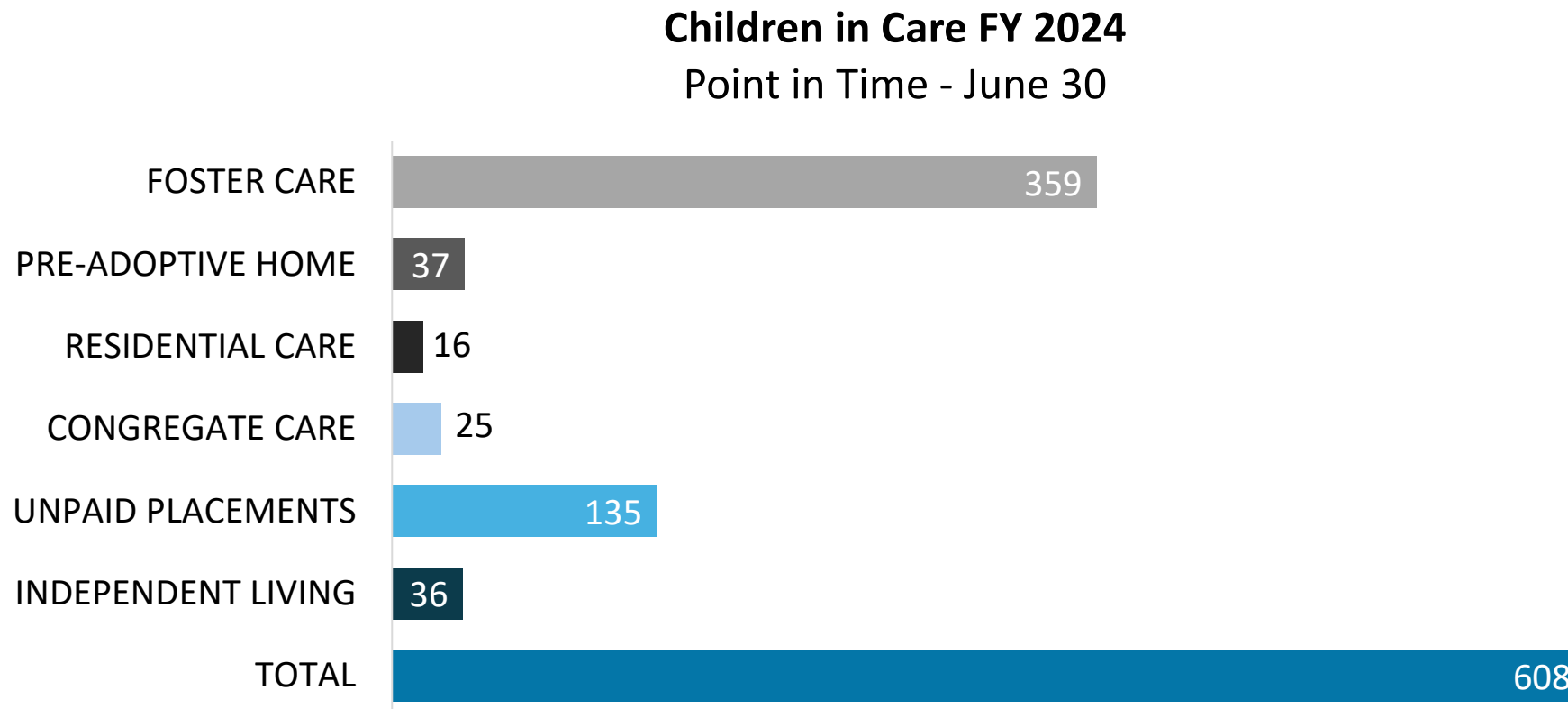
# Removals

When an investigation occurs and there are no reasonable efforts that will keep the child safe in their home or there is a present danger of serious harm in the home, then the child is subject for removal. Removing a child from their natural environment is a final recourse of the overall extent of services provided.



# Foster Care

When children must be removed from their homes, foster care is a temporary resource for placement to meet the needs of the child who's birth parents or guardians are unable to care for them. This includes, but is not limited to, placements in foster family homes, foster homes of relatives, emergency homes, residential facilities, child care institutions and pre-adoptive homes.

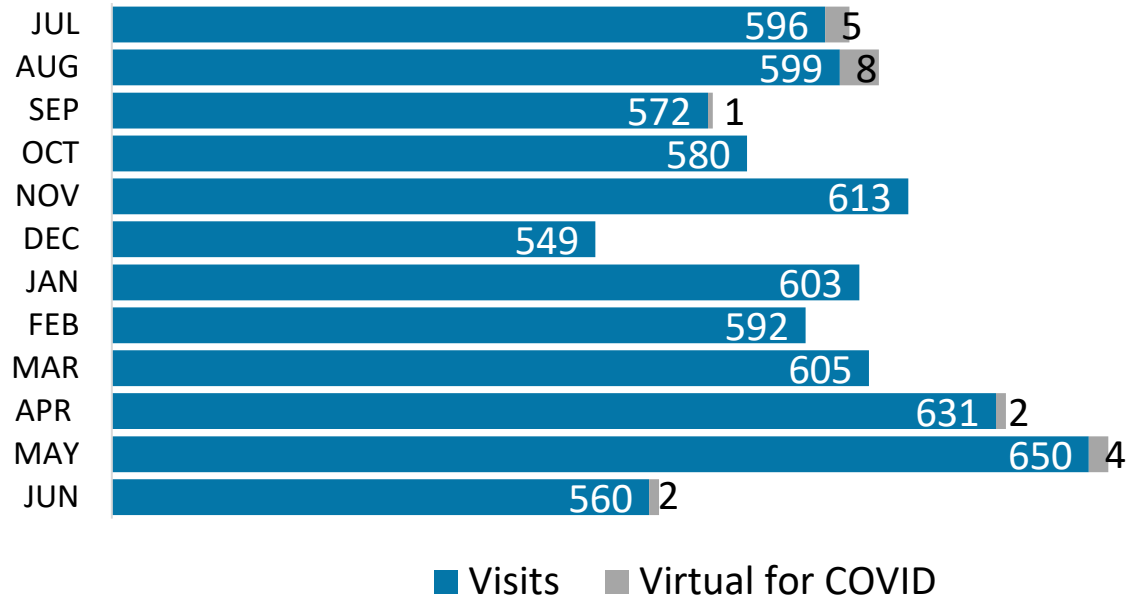


# Family Engagement Center

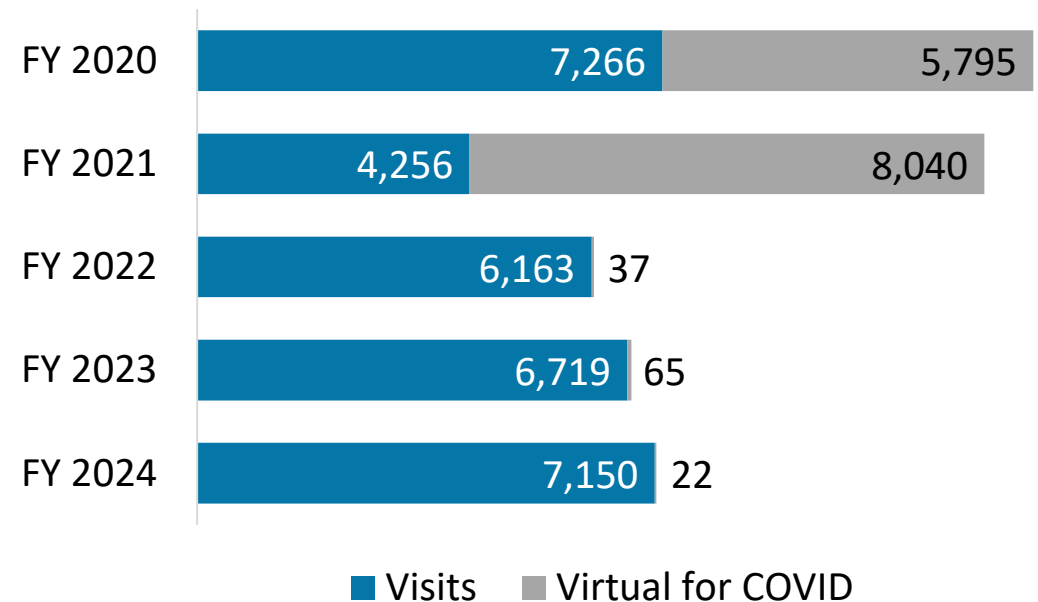
When a child is removed from their home, often times, the parent's only interaction with them is during a scheduled supervised visitation. The purpose of supervised visitation is to ensure that parents are capable of interacting and spending time with their child, without placing them at risk of being harmed.

The Family Engagement Center (FEC) is a focal point for family connection, allowing families working toward reunification to have a place of exploration and healing to call home. The FEC creates a positive family dynamic that is key to strengthening parent-child relationships and improving patterns of interaction that build a safe and stable home, not only for the child's well-being, but for the family as a whole.

## Monthly Visitations FY 2024



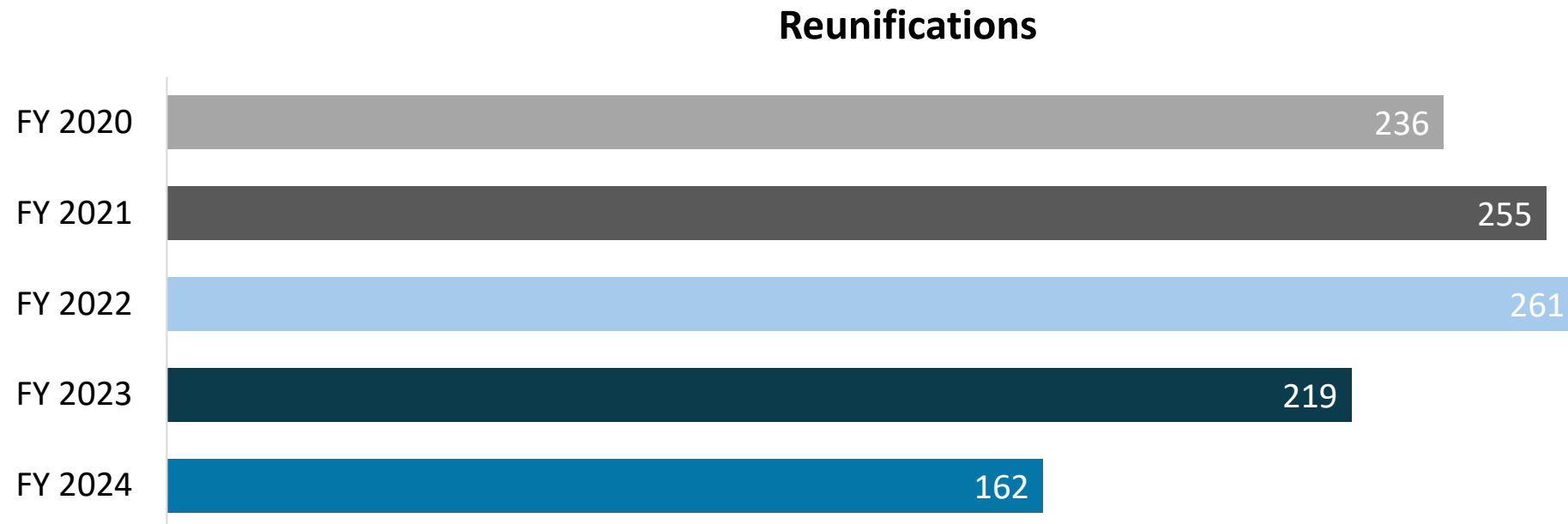
## Yearly Visitation Totals FY 2024





# Reunifications

When children are in the foster care system, the first goal is to reunite them with their families as soon as possible. WCHSA implements multifaceted strategies to help build on family strengths and address concerns. Such strategies may include family engagement, maintaining family and cultural connections, connecting families to evidence-based services, regular and frequent visits among family members and with the worker, and parent education, among others. Returning children home often requires intensive, family-centered services to support a safe and stable family. Services are tailored to each family's circumstances and address the issue(s) that brought the child and family into the child welfare system.

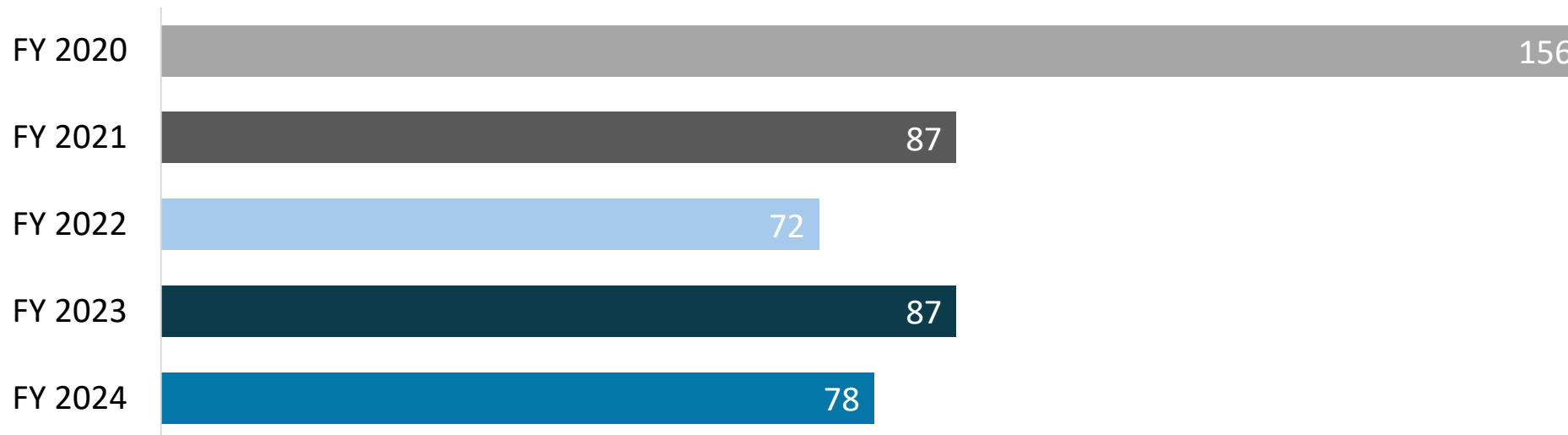




# Adoptions

Foster children of all ages in the child welfare system await permanent homes when the rights and responsibilities of their biological parents have been permanently terminated by court order. Adoption is the process that transfers those social and legal rights, responsibilities and privileges of parenting to another individual or married couple whom did not have that relationship by birth- allowing them to become the child's legal parent(s). They will have the same rights and obligations that exist between a child and their biological parents. The primary purpose of adoption is to provide children with a committed family that can give them the love, care, protection and opportunities essential for their health, personal growth and development. The main objective of the placement of children for adoption is the well-being of the child. The Adoption Services program is child-focused and strives to find families for children, not children for families.

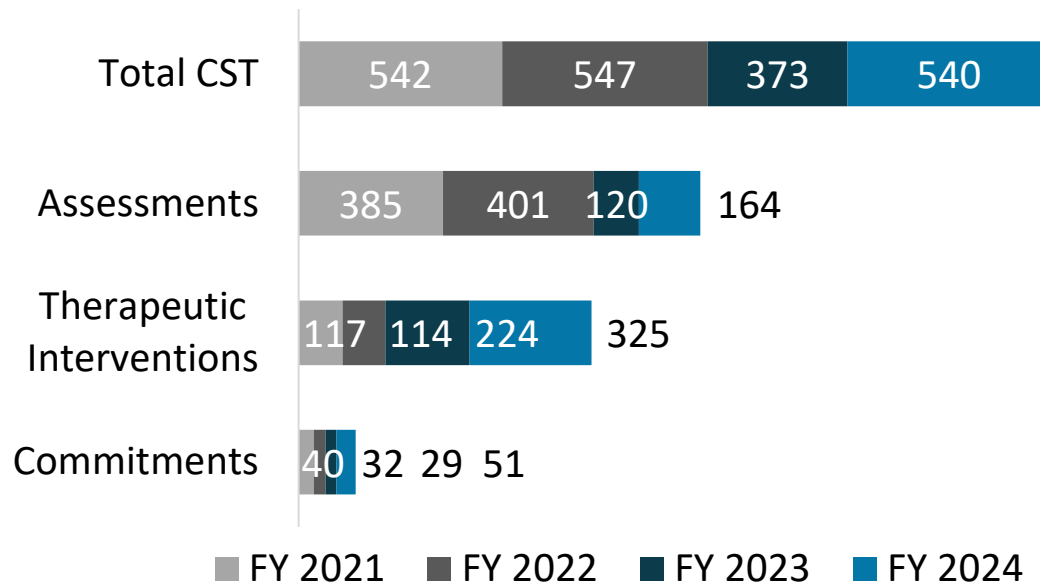
## Finalized Adoptions



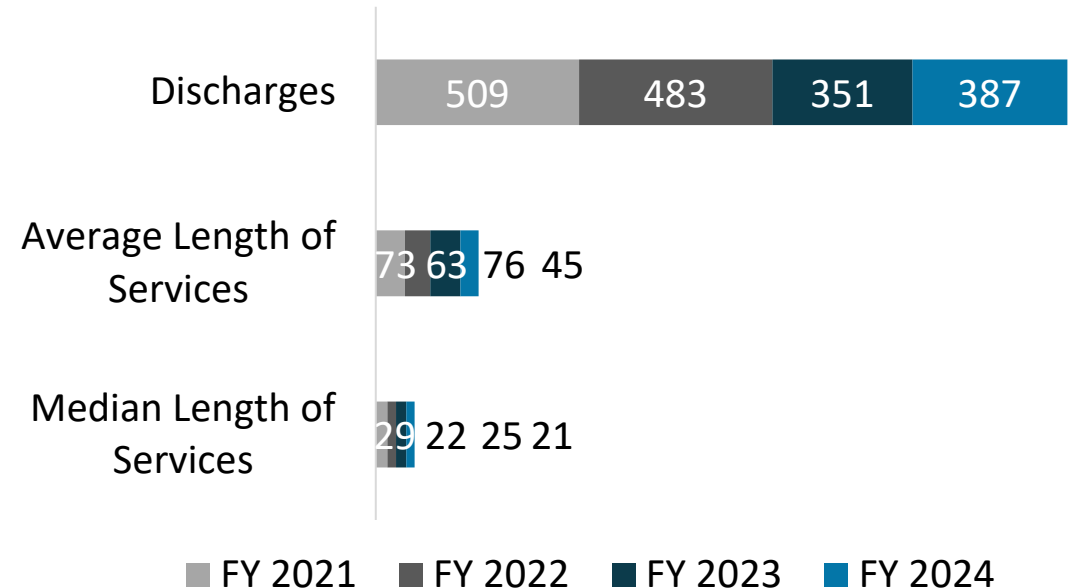
# Clinical Services

Clinical services is comprised of a Clinical Services Team (CST), who provide short-term, evidence-based mental and behavioral health services to clients involved in the programs within WCHSA. CST is designed to ensure the psychological and emotional well-being of children, parents, caregivers; and families, by addressing their identified behavioral or mental health needs. The Clinical Services Team can be involved prior to or at the beginning of a child welfare report or case; during the life of a child welfare case; or upon permanent placement of children. All CST clinicians adhere to strict standards of confidentiality.

# Adult Services

The Mission of Adult Services is to implement and administer programs that provide human services to all eligible individuals and families by providing referrals, support, prevention, outreach and relief to persons who are indigent, medically needy or at-risk in a courteous and timely manner. The Adult Services Division provides case management services for those individuals in nursing homes and adult group care settings. Adult Social Services also provides coordination and payment for burial and cremation services to Washoe County residents. In addition, the Adult Services Division provides payment to the homeless shelter; as well as, operating a supportive living program.

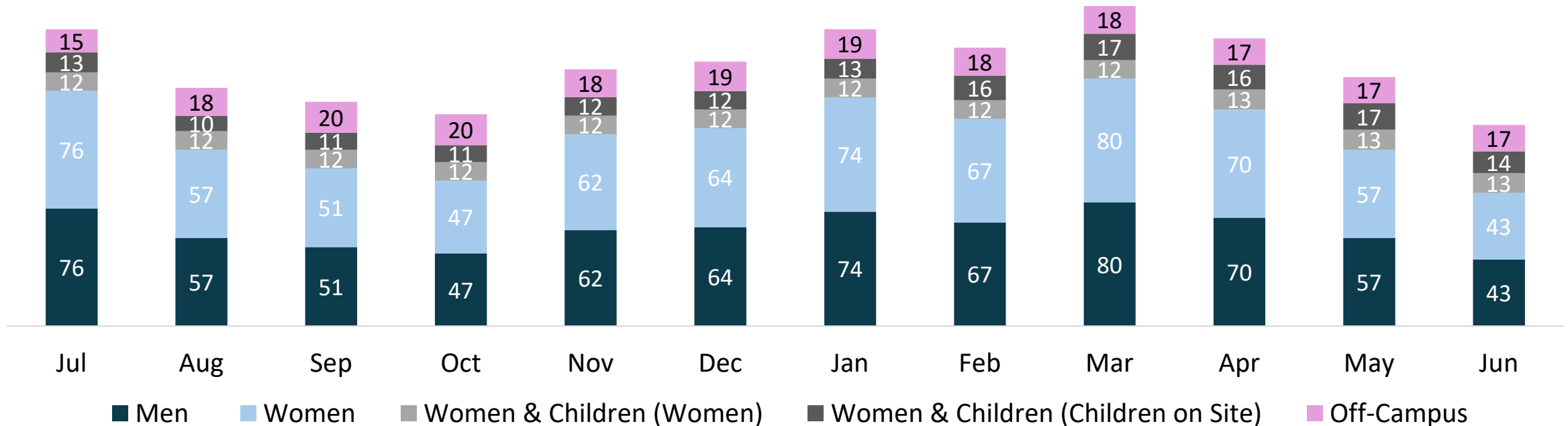

# CrossRoads

CrossRoads is a WCHSA lead initiative providing a tiered/modified housing first approach, through effective programming, services and community collaboration. The program works to identify, intervene and stabilize highly complex individuals in Washoe County who are generally homeless and may be suffering from a substance use disorder, mental health condition or both. Individuals who qualify for the CrossRoads program are provided with a wide- range of support and services based on their individual needs.

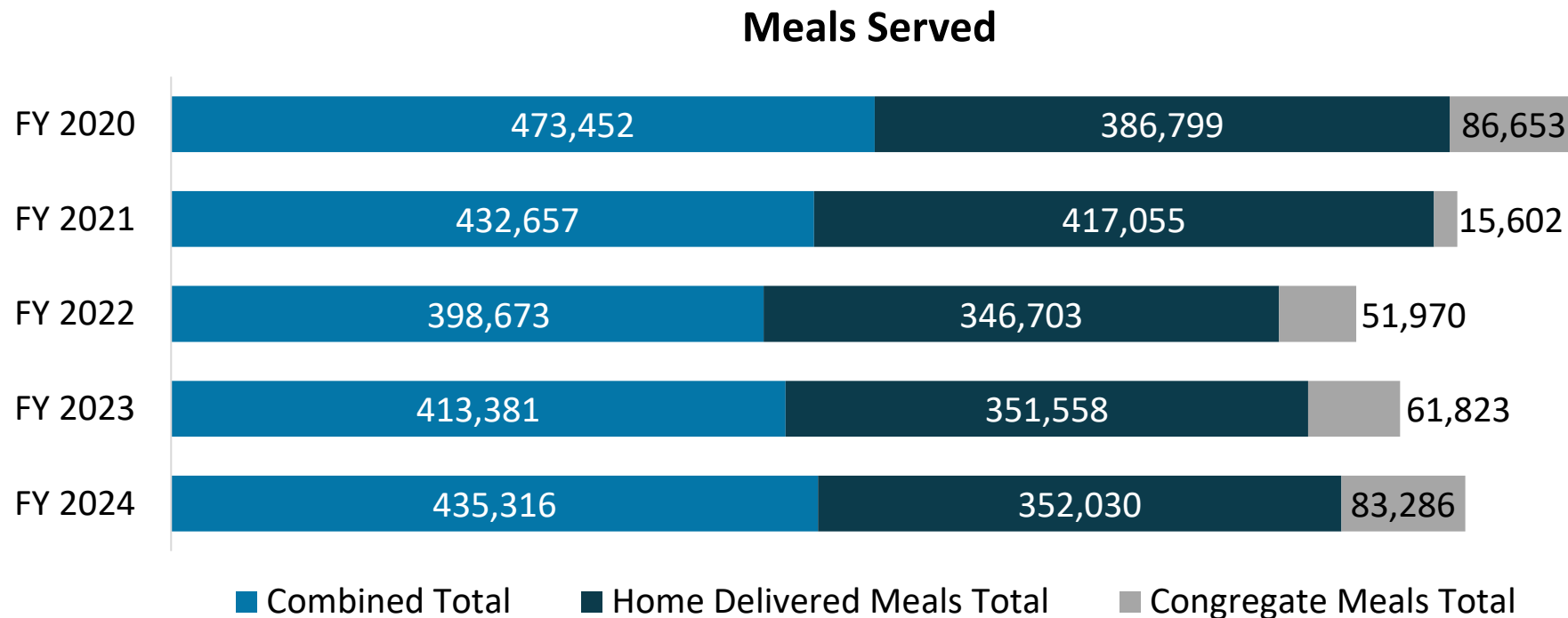
By maximizing opportunities to create fulfilled relationships, HSA's goal is to build every aspect of viability for all aging residents and maintain happy, healthy communities.

# Nutrition

The Nutrition Programs supply well-balanced meals daily to Washoe County's senior population. Meals provided are in accordance with established dietary guidelines and food safety standards. The Nutrition Programs fall into two categories, Home Delivered Meals, which Provides delivery of meals to homebound seniors 60+ who are unable to participate in the Congregate Meal program due to an illness or a disability. Congregate Meals, which provides one hot meal or fresh salad for lunch Monday through Friday to seniors 60+ and qualified individuals at ten senior meal locations.







# Housing & Homeless Services

The mission of the Housing and Homeless Services Division, is to work toward minimizing homelessness throughout Washoe County by leading the community in building a system that is capable of housing people experiencing homelessness. Services and support are provided so that homelessness becomes rare, brief, and non-reoccurring.

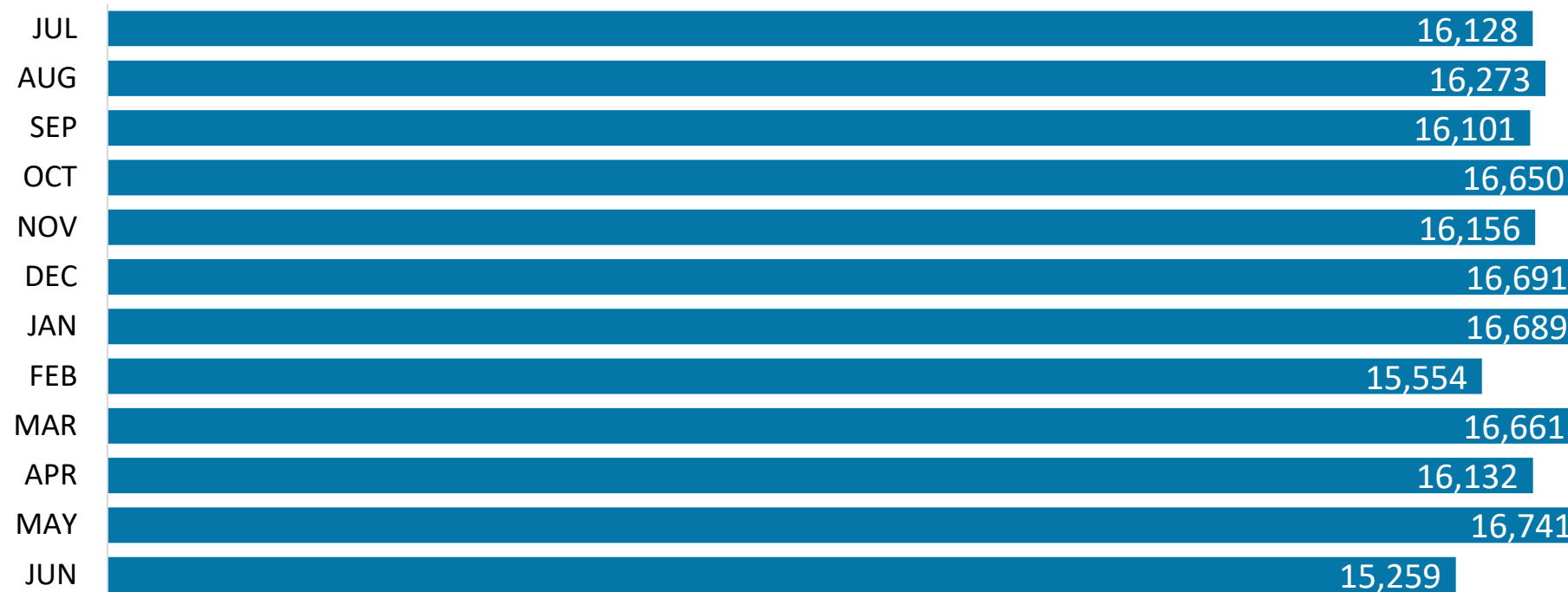

Case management, behavioral health support and other community partners will be on-site to provide support and provide assessments and referrals for needed services. The Campus provides basic facilities including restrooms, handwashing stations, laundry, showers, and meals.

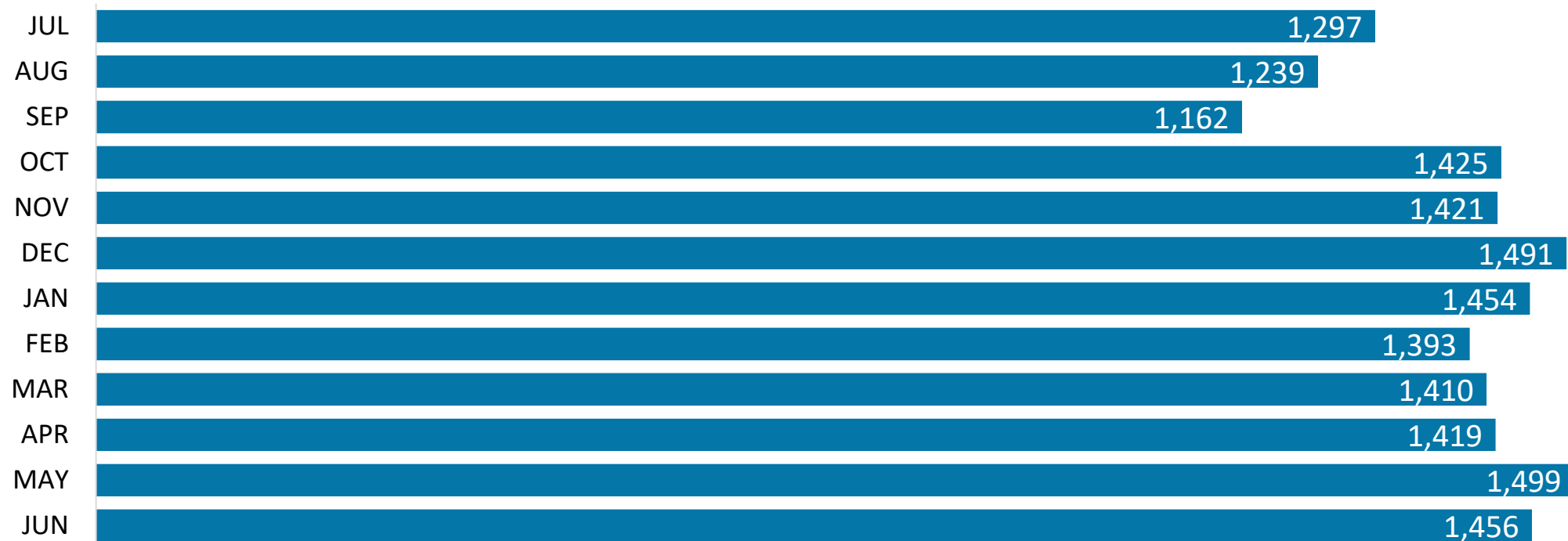

# Our Place Family Program

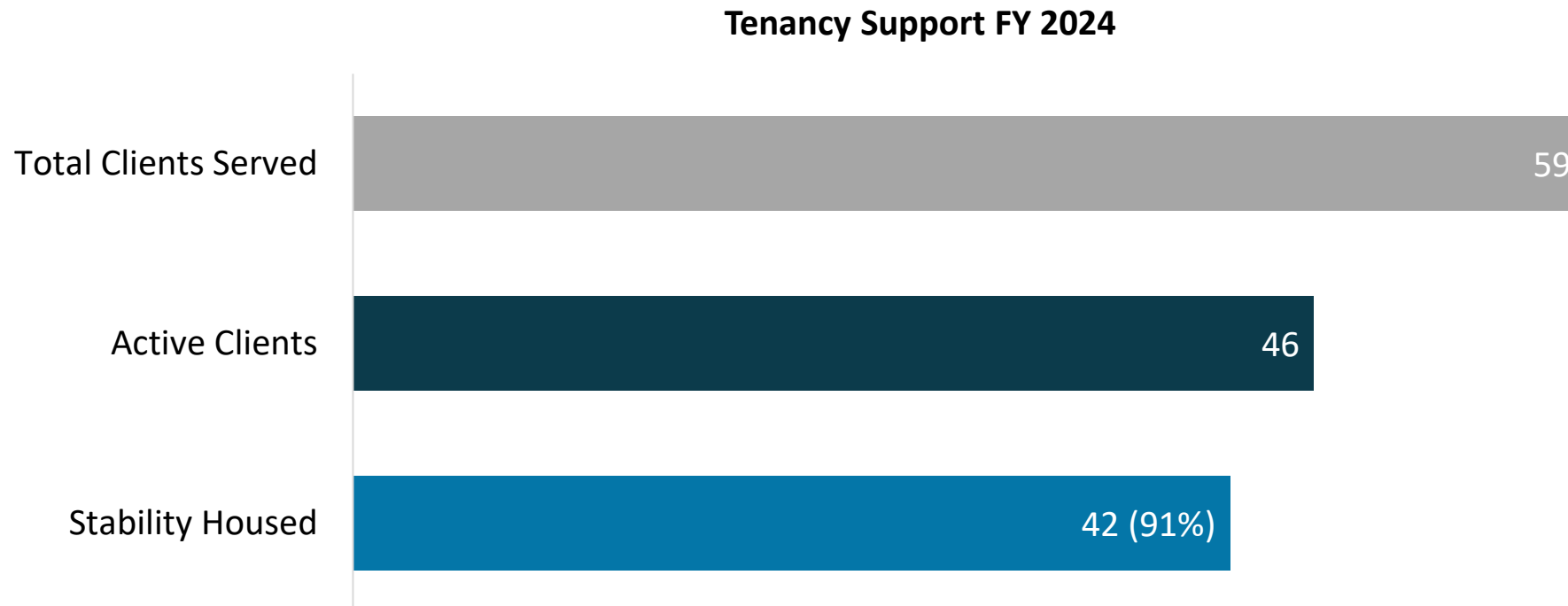
