Welfare of Inmates COVID-19 Update

- Steps taken to mitigate COVID-19 threat to jail population
 - Cancelled all in person contact with inmates
 - Increased iWeb, telephone, email access
 - Cancelled all inmate transports outside facility
 - Cancelled all inmate programming
 - COVID education campaign
 - Waived medical assessment fee
 - Creation of Isolation/Quarantine Unit
 - Created COVID-19 pre-screening station in Intake
 - Reduced tier time numbers for social distancing
 - Started testing ALL new inmates prior to being transferred to General Housing
 - Issued masks to all inmates traveling outside their assigned housing unit



Housing Unit Re-Organization


- ▶ Housing Unit 1 will become the Male Intake Unit.
- Housing Unit 2 will remain the Female general population unit.
- Housing Unit 3 will become the Female Intake, Female Ad-stat and Female Mental Health unit.
- Housing Unit 4 will stay the male Ad-Stat unit.
- ▶ Housing Unit 6 will become a general population unit and inactive gang members.
- Housing Unit 7 will become a general population unit.
- ▶ Housing Units 8, 9, 11, 12, 13, 14 and 15 will not change.
- Housing Unit 16 will become the new Mental Health Unit, focusing on the Inmates willing to take their medication and attempting to graduate the mental health program.
- Housing Unit 17 will accommodate the Mental Health and Ad-Stat inmates that are behavioral issues and have unpredictable erratic behavior.


Mental Health Concerns

- Special Watch cells at capacity
 - ▶ Intake Cells 1 & 2 Conversion (CIP)
- Suicide attempts up 136% last quarter (11 to 26)
- Suicide attempts down 88% this quarter (26 to 3)
- Averted attempts up 34% last quarter (206 to 277)
- Averted attempts down 10% this quarter (277 to 250)
- Bunk Project is moving forward
 - Awaiting final contract award (CIP)
 - Over 700 bunks to be fabricated

FY 20/21 4th Quarter Average Daily Population






FY 20/21 4th Quarter Bookings




FY 20/21 4-Year Average Bookings

FY 20/21 4-year Comparison Average Length of Stay







Washoe County Detention Facility Inmate Work Program

Mission

- Ensure overall cleanliness and hygiene of the Detention Facility.
- Schedule and coordinate workcrew assignments based on priority and community need.
- Train crew members in approved work methods and procedures required to perform specific grounds/building maintenance, custodial work, painting, light construction, snow removal, graffiti abatement, and river clean up.
- Instruct workers in the appropriate and safe operation of equipment and the performance of basic preventive maintenance on custodial and grounds maintenance tools.
- Maintain adequate inventory of supplies, tools, equipment, and replacement parts for the performance of work crew assignments.
- Community Service
 - Dedicated to providing clean up, graffiti removal and maintenance services throughout Washoe County.
 - Incline Village partnership to maintain a graffiti free community
 - Currently working closely with Homeless Outreach Proactive Engagement (HOPE) Team
