### **SUMMARY**

Replacement of Wittenberg Hall recreation yard artificial turf and approval of cross-fund budget appropriation transfer from Juvenile Services Targeted Case Management Fund to the Capital Improvement Fund – PW920428 - JS Recreation Yard Turf Replacement.

### **PREVIOUS ACTION**

### **BACKGROUND**

When the Jan Evans Juvenile Justice Center was opened in 2004, grass was planted in the detention facility, Wittenberg Hall, recreation yard. Due to various issues with initial design, artificial turf was installed in the recreation yard approximately two years later. The current artificial turf has exceeded useful life and is in need of replacement to maintain safe use by the juveniles housed in Wittenberg Hall.

This off-cycle capital project was reviewed and approved by the CIP Committee. Funding for this project is supported from Juvenile Service Target Case Management Fund.
