SUBJECT: Recommendation to accept the FY 2022 Joining Forces award from the State of Nevada Department of Public Safety, Office of Traffic Safety [amount not to exceed \$96,000.00, 25% In-Kind county match required] to cover overtime costs related to conducting traffic enforcement checkpoint events and limited travel expenses, for the grant term of October 1, 2021 through September 30, 2022 and if approved, direct Comptroller's Office to make the necessary budget amendments; and authorize Sheriff Balaam to execute grant award documents. (All Commission Districts.)

SUMMARY

This grant has been awarded to cover overtime costs allowing our agency to participate in various traffic enforcement events, such as Joining Forces, scheduled by the Office of Traffic Safety (OTS), as well as limited travel expenses.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

On September 8, 2020, the Board accepted Item 5.G.1., Joining Forces funding from the State of Nevada for traffic events and limited travel.

On September 24, 2019, the Board accepted Item 7.I.4., Joining Forces funding from the State of Nevada for traffic events and limited travel.

On December 11, 2018, the Board accepted Item 7.G.4., Joining Forces funding from the State of Nevada for traffic events and limited travel.

On September 26, 2017, the Board accepted Item 5.G.5, Joining Forces funding from the State of Nevada for traffic events and limited travel.

The Board has been approving Joining Forces funding from the State of Nevada for traffic events and limited travel since 2013.

BACKGROUND

The Washoe County Sheriff's Office has been awarded a grant with the Nevada Office of Traffic Safety to continue to conduct traffic enforcement checkpoints and enforcement events throughout Federal FY 2022. This grant will pay for overtime costs incurred by commissioned staff for enforcement efforts that are scheduled by Office of Traffic Safety throughout the grant period of October 1, 2021 through September 30, 2022. This funding also pays for limited travel costs to specific events as approved by the grantor.
