  - **SUBJECT:** Recommendation to approve State Public Library Collection Development Project Grant-In-Aid Award funds from the State of Nevada in the amount of [\$17,879.00, no local match required] for a term retroactive from October 7, 2022 through June 30, 2023 for the augmentation of the digital library collection to increase the number of in-demand downloadable library materials, direct the Comptroller's Office to make the necessary budget amendments; and the Director to sign the grant award documents. ## **SUMMARY**

The Library is requesting Board approval of the State Public Library Collection Development Project Grant-In-Aid Award funds from the State of Nevada in the amount of [\$17,879.00, no local match required] for a term retroactive from October 7, 2022 through June 30, 2023 for the augmentation of the digital library collection to increase the number of in-demand downloadable library materials, direct the Comptroller's Office to make the necessary budget amendments; and the Director to sign the grant award documents.

## BACKGROUND

In September 2022 the Nevada State Library, Archives & Public Records announced a formula-based grant for fiscal year 2023 for the purchase of books and library materials. Washoe County Library System submitted an application for the grant called the Shorten the Wait project, which would augment the digital collection with these formula-based grant monies in order to reduce holds ratios and decrease patron wait times for in-demand digital titles. If approved, these grant monies will be used to purchase additional copies of digital titles, which will directly benefit library patrons by making it easier and faster to obtain popular, in-demand eBooks and downloadable audiobooks.

The reason for a retroactive approval is because award documents were received on September 23, 2022 with a project start date of October 7, 2022, and documents were submitted at the earliest available BCC meeting.

## GRANT AWARD SUMMARY

**Project/Program Name:** Shorten the Wait (State Public Library Collection Development Fund Project)

**Scope of the Project:** Washoe County Library System will purchase additional OverDrive copies when holds ratios are greater than 5 holds per copy. Current data shows that the Library catalog contains more than 500 titles on OverDrive that exceed this holds ratio, with 30 titles exceeding a 10:1 holds ratio. The Library will use this year's State Grant-In-Aid to purchase additional copies to shorten the wait time.

**Benefit to Washoe County Residents:** Patrons have embraced eBooks and downloadable audiobooks but become frustrated with lengthy wait times for popular titles. Patrons indicate what they'd like to see more of by making requests and placing holds. The Shorten the Wait project will provide more of these in-demand titles to the community, and the increase in quantity will lead to a decrease in wait times for each title. It will be easier and faster to obtain popular eBooks and downloadable audiobooks.
