BACKGROUND

As part of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) of 2020, ELC awarded funds to rapidly establish and monitor key activities related to COVID-19 in the areas of epidemiology, laboratory and informatics. Monitoring the indicators associated with these activities are intended to assist States, local and territorial governments in making data-driven policy decisions regarding testing, mitigation, and prevention efforts.

The District Board of Health accepted this subaward at their July 23, 2020 meeting.

GRANT AWARD SUMMARY

Project/Program Name: ELC CARES Grant

Scope of the Project: This Subaward provides funding to carry out surveillance, epidemiology, mitigation, and other COVID-19 response activities.

Benefit to Washoe County Residents: Provides surge capacity for the Health District to respond to the pandemic.

On-Going Program Support: The program will continue to apply for funding to support the crisis response.
